Issue	Concerns and comments	Department response
Opening palila mitigation areas to game bird hunting in Units A and G	5 letters opposed adding one or both mitigation areas to game bird hunting units because of the very sensitive nature of this habitat for palila recovery. Comment: The shooting, trampling, presence of dogs and other disturbances are not conducive to restoring habitat and populations of this bird that is so close to extinction. The two mitigation areas should be designated as permanent palila wildlife sanctuaries and managed appropriately. There are extensive game bird hunting opportunities within the Mauna Kea Forest Reserve, in fact far in excess of demand. Comment: The MOU for the Puu Mali mitigation parcel reportedly requires that the parcel be used for hunting if it will not impact palila. It would be extremely difficult if not impossible to demonstrate no impact without a rigorous, continuous monitoring program that extends far beyond where hunting will take place.	<p>The department recognizes that the purpose of the establishment of the Puu Mali mitigation parcel, as identified in the MOU, is primarily for the recovery of Palila. However, the MOU addresses the issue of public bird hunting in the parcel and provides for that use if it does not negatively affect the restoration of the parcel for Palila recovery. Further, the Puu Mali parcel represents public trust lands, which, under the state constitution, shall be managed for the benefit of the people of Hawaii. It is the position of the department that bird hunting should be allowed in the parcel if it can be conducted in a manner that does not interfere with the restoration of the parcel.</p> <p>The department conducted an analysis of the potential conflicts and compatibility of bird hunting and restoration in the parcel and concluded that bird hunting was not likely to interfere with restoration if restricted to certain portions of the parcel with appropriate regulation of hunting activities. The department concluded that bird hunting should not be permitted in the central portion of the parcel where restoration activities are most intensive. The department recommends that the proposed rule amendment be adopted to allow bird hunting as proposed. Staff will be assigned to monitor the use of the parcel to document any undesirable effects. If conflicts with restoration are identified bird hunting can be restricted to address the problems.</p>
	1 letter said that the proposed extension "is incorrect and must be extended to the full described area defined in 'Final Environmental Impact Statement--Saddle Road (State Route 200) Mamalahoa Highway (State Route 190) to Milepost 6' (Hereafter referred to as FEIS...Failure to abide by the provisions of the FEIS leaves the participating agencies open to litigation." This letter also said that the references to Puu Mali Mitigation Site and Kaohe Mitigation Site in the draft rules for Chapter 122 and in associated Exhibit 2 are "being adopted as rule without any definition, purpose or restrictions. There is no enabling law or rule that allows this specific inclusion. Therefore, their references must be deleted from the rules."	The hunting rules do not represent any aspects of the EIS or its findings. With regard to the proposed establishment of the Puu Mali mitigation site as a PHA, authorization to do so is provided in Chapter 183D-4, Hawaii Revised Statutes.
Changing designation of Unit A from Mauna Kea GMA to Mauna Kea Forest Reserve with liberalized game mammal take.	13 letters and recorded comments opposed the proposed changes, including one letter with 15 signatures attached and one with 9 names typed at the bottom. With 1 exception (which centered on lack of Ramseyer format in the draft rules maps), opposition focused on the resulting likelihood of area closure or game animal eradication, and on a preference for keeping this a sustained-yield area for pig hunting. 1 additional letter did not mention the change to Forest Reserve, but opposed ending bag limits for sheep and goats and asked what the scientific justification is for this step. Comment: This should remain one pig per hunter per day and special seasons should also apply. Comment: I oppose the change in the rules taking away the name Game Management Area to Forest Reserve in all areas on all islands.	The subject area was established as a Forest Reserve and later as a GMA and is presently considered by the department to be both. We therefore recommend that the designation as a GMA be recognized in the rules. With regard to bag limits, the department intends to comply with the Palila court orders for sheep and goats but may set bag limits and conditions for other game species for game management purposes.
Unit A	Comments received expressing concerns about liberalized hunting.	Conditions are liberalized in unit A in compliance with the palila court orders for the purpose of restoring Palila Critical Habitat. The scientific justification for that action is provided in the court documents and in numerous scientific publications (see, e.g., Revised Recovery Plan for Hawaiian Forest Birds (2006). See also Exhibit 1, Item 1
Unit A	1 person stated that because the map in the draft rules exhibit does not show Mauna Kea GMA, Ramseyer format is not adhered to and the rule change is therefore invalid: No substantial countermanding rule change deleting the original MKGMA has been enacted since the original 1951 rule, so all official DLNR hunting maps relating to Unit A are legally required to reference MKGMA, which is not done in the map in the draft rules exhibit. This letter also said that the Board cannot adopt policy that would have the effect of amending a rule without following HAPA requirements.	The department has followed all required procedures under chapter 91 (HAPA) for a rule amendment. According to section 91-4.1, the department, "shall prepare a certified copy of the rule changes according to Ramseyer format." This requirement has been followed.
Unit A	Comment that another public hearing may be required if substantial changes are made to the rule after a public hearing, and that DLNR's primary function in the MKGMA is game management. Deleting the MKGMA rule designation is a substantial change of land use and emphasis, so if the GMA is deleted, that act meets the test requiring another public hearing.	The department has followed all required procedures under chapter 91 for a rule amendment, including holding public hearings for all substantive proposed changes.
Unit A	1 comment suggested reevaluating public hunting as a use in Unit A because of high conservation values, to assure that conservation of native flora and fauna is given the greatest consideration in managing for nonnative game species. If hunting is not removed from units B, C, and K, then the writer supported keeping Unit A open daily and year-round, with no bag or season limits for mammals and game birds.	See Exhibit 1, Item 1
Unit A	1 person who did not specify Unit A or any hunting area in their comment said that "If changing the name to Forest Reserve means that the department will better manage areas for all uses then we support it...uses of the land and the number of users continues to increase." 1 person expressed grave concern about the palila and their habitat: Please remove all ungulates from the palila habitat and fence it securely as soon as possible.	The department concurs with the concerns expressed for the recovery of Palila and intends to comply with the court order to remove all sheep and goats from Palila Critical habitat and to implement the Revised Recovery Plan for Hawaiian Forest Birds (2006) for the recovery of Palila.

Opening bird hunting on Wednesdays and Thursdays in Big Island Units A, G, PTA and private lands	3 comments supported this change, while 1 expressed concern: Comment: This especially benefits retirees and people employed by the tourism industry (such as in West Hawaii) who have to work on weekends. Comment: I'm glad to see this; my question is why can't it just be every day of the week. As the gentleman gave before, most of us who are retired...to pile everybody on a couple of days just seems to be looking for trouble. And why end on Martin Luther King Jr. Day instead of January 31st, that kind of takes the math out of it, just November 1 to January 31. Comment: The history was that a lot of hunting lands bordered plantations or farms, so it was done on weekends and holidays, for safety reasons. I would like to see it like on the mainland, we go hunting birds seven days a week. It's not too much hunting, it lessens the pressure and you can do better management that way.	The department conducted a survey of licensed hunters designed to make an assessment of the level of support among hunters for the addition of week days to the game bird season. The survey found that the majority of hunters do support the addition of 2-3 weekdays and the board approved the addition. The department recommends that the proposed addition of W-Th be adopted based on support from the majority of hunters.
	Comment: The general consensus of the bird hunting community regarding the 2007/2008 hunting season in Mauna Kea GMA, Kaohe GMA, and PTA, when Wednesday/Thursday hunts were allowed, was that it was dismal. Reinstating the Wednesday/Thursday hunts without regard to predictive seasonal weather patterns, correlative statistical analysis, actual bird counts and adjustment of allowable game takes will once again become a poor substitute for good game bird management and risk affecting the quantity of hatchling brood stock. I urge you to reconsider this proposed rule change of instituting Wed/Thurs hunts without any qualifications.	The department does conduct monitoring of game bird populations and the biotic and abiotic factors that potentially influence those populations and analyze those data to guide management. Preliminary data on the W-Th addition does not suggest that it results in more hunters overall. The department recommends that the proposed amendment to add W-Th be adopted and followed by monitoring to determine whether the game bird populations are able to sustain the addition of those days.
Hunting in Unit A for game birds and rifle hunting for mammals at the same time	5 letters opposed the change, including one letter with 15 signatures attached. Opposition focused on safety of both dogs and other hunters, and suggested this could be solved with rifle hunting for mammals on weekdays and bird hunting on weekends during bird season.	All hunters are required to follow strict safety protocols, including completion of a certified hunter safety course maintaining a valid hunting license. The department also notes that bird hunting and big game hunting areas and times overlap in many western states.
	Comment: Restricting firearm mammal hunting during bird season to above treeline does not protect bird hunters since projectiles from a rifle can travel great distances.	All hunters are required to follow strict safety protocols, including completion of a certified hunter safety course maintaining a valid hunting license. The department also notes that bird hunting and big game hunting areas and times overlap in many western states.
	Comment: Dogs are at particular risk depending on their color. Some hunters will take a long-distance or fleeting-identification shot. Chukar hunters and dogs remain in jeopardy above and below "treeline" whatever that means. This rule creates a dangerous situation that I believe would not be acceptable with the waivers we sign on our hunting licenses.	All hunters are required to follow strict safety protocols, including completion of a certified hunter safety course maintaining a valid hunting license. The department also notes that bird hunting and big game hunting areas and times overlap in many western states.
ATVs in Unit A	1 comment outlining problems: Since ATVs have been allowed in the Mauna Kea GMA, the roads have become really bad, and the ATVs do not stay on the roads. They are making their own trails, damaging the landscape, speeding on the roads, and hunters using ATVs makes enforcement harder.	ATVs: Under section 13-123-22 (4)(C), ATVs may be used only on roads that are constructed, maintained, and opened for vehicular use. The department recognizes the potential impacts of ATVs on roads and strives to maintain the roads for public use. To the extent that ATVs may be illegally used of roads and damage natural resources, the department seeks to enforce all applicable laws and prosecute violations. The department recognizes the limitations of personnel and funds that may prevent us from achieving desired levels of maintenance and enforcement and is committed to securing the resources needed to improve those capacities. Recent trends have seen an enhancement in the department's management capacity and we are optimistic that those trends will continue. With regard to Unit A, the use of ATVs is also regulated and permitted under the forest reserve rules, chapter 13-104, and may be prohibited if their use creates unacceptable damage to roads and resources.
Unit A and Kau Forest Reserve should not be public hunting areas	1 comment: These two areas are highly sensitive and intact areas that are home to native and listed species. These areas should be managed for these resources with priority given to conservation, as other areas are available for hunting.	See Exhibit 1, Item 1
Hunting in Unit B	1 letter suggested that public hunting be removed from Unit B (Piha section) because of the high conservation value of the areas and their proximity to Hakalau Forest NWR and Laupahoehoe NAR, and supported implementing a management scheme to enhance endangered species and recovery efforts there. If this is not done, the writer supports changing management to no bag limits and year-round daily hunting and no season limit for mammals and game birds.	See Exhibit 1, Item 1
	1 person opposed removing unencumbered lands of Manuka Kalaumana and Kipahoehoe from Unit B. Comment: I think all unencumbered state land should be left open for hunting.	The subject lands are still available for public hunting, they are being proposed to be redesignated as Unit K since they are contained within larger sections of unit K.
Hunting in Unit C	1 letter suggested that public hunting be removed from Unit C (Hilo Forest Reserve Laupahoehoe and Piha section) because of the high conservation value of the areas and their proximity to Hakalau Forest NWR and Laupahoehoe NAR, and supported implementing a management scheme to enhance endangered species and recovery efforts there. If this is not done, the writer supports adding goats as game mammals to be taken, with no bag or season limits and daily hunting; also daily year-round hunting with no bag or season limits for game birds.	See Exhibit 1, Item 1
Removing the requirement for telephone reservations for Unit C	7 letters and recorded comments came in, all in opposition. Three of these, one with 15 signatures attached, also suggested a limit of eight hunters per day for Piha and 12 per day for Laupahoehoe. Opposition to eliminating reservations was based on the small size and popularity of the unit. Comment: I'm opposed to any changes in area C. There should be game wardens up there every weekend. Funny, we go up there and there's dog guys in there and we have to call in to Honolulu to report it? That's stupid. They'll never catch anybody that way.	After employing the telephone reservation system for many years the department has found that the system is used by only a very small number of hunters while requiring significant personnel resources to maintain. The department recommends that the amendment be approved as proposed.
Unit C take limits	3 comments requested a change of bag limit from two pigs per hunter per day to one pig per hunter per day 1 comment supported daily hunting vs. weekend/holidays only.	The department does not concur. The unit is designated for no dogs, weekends and holidays only, and usage in these areas is relatively low. Since this results in generally lower harvest the department prefers to allow a higher bag limit when possible. See Exhibit 1, Item 1

Removal of Haao Springs from Unit D	4 comments, all opposing. Comment: This is a popular hunting area for local Kau residents. Comment: A structured management rule should be implemented rather than a full closure. Comment: I oppose any closing of any areas you're proposing right now because our island is constantly shrinking and what we have we want to hold on to.	Haao Spring Restricted Watershed would still be open for hunting and is now included in an expanded Unit B, with the same hunting rules as the nearby Kau Forest Reserve.
Unit D take limits/hunting	1 comment encouraged daily hunting of mammals with no bag limit. 1 comment supported daily hunting vs. weekend/holidays only.	See Exhibit 1, Item 1
	1 comment suggested reevaluating public hunting as a use in Unit D because of high conservation values, to assure that conservation of native flora and fauna is given the greatest consideration in managing for nonnative game species. If hunting is not removed from units B, C, and K, then the writer supported keeping Unit D open daily and year-round for mammals with no bag limit, and open daily and year-round with no bag or season limits for game birds.	See Exhibit 1, Item 1
Unit E designations	3 letters, including one with 15 attached signatures, agreed with the designation change to Puu Anahulu GMA, East Section. These letters and 2 more said Pohakuloa Training Area should continue to be designated as a GMA with specifically numbered hunting areas, and that the areas should be more specifically listed. Comment: If the numbered areas are removed, the DLNR or the military will be able to close any area to hunting since it will not be listed in the regulations as having to stay open. The 1964 lease says the area shall be managed for hunting, so it should be sustained yield. 2 letters said Area 21 should not be removed as it was open for hunting in the past.	The department concurs that PTA hunting areas should be identified on the maps with specifically numbered hunting areas. With regard to sustained yield, see Exhibit 1, Item 1. With regard to Area 21, that parcel is federal land, the department has no jurisdiction to manage hunting there.
Unit E, take limits in Kipuka Ainahou/Mauna Loa GMA	12 recorded comments and letters, one with 15 signatures attached and one with 9 names typed at the bottom, opposed liberalizing take limits in Kipuka Ainahou (the letter with multiple signatures specified take limits in Mauna Loa GMA, including Kipuka Ainahou). Comment: by extending the bag limit for Kipuka I feel that the department is now going for eradication and not management, same for Kaohe area. Comment: Kipuka Ainahou is one of the last archery areas where game is plentiful and chances of success are good. My grandfather told me that goats were abundant years ago. From the stories, they were all trapped out at night due to poor game management and enforcement. We have also noticed a rise in wild dogs which is becoming a threat to safety. Comment: It should stay the same one pig, one goat and one sheep!	See Exhibit 1, Item 1
	1 comment supported daily hunting vs. weekend/holidays only, and a few comments supported the continuation of the March-October archery-only designation.	See Exhibit 1, Item 1
	1 letter that favored eliminating all take restrictions on wild ungulates described the area (since it became an archery hunting site with small bag limits) as a breeding ground for mouflon, which compete for food resources with the nene in the Kipuka Ainahou Nene Sanctuary.	See Exhibit 1, Item 1
	1 letter said that reference to Mauna Loa GMA in the game bird and game mammal rules should be corrected to Mauna Loa Forest Reserve as there is no Mauna Loa GMA pursuant to HRS 183D-4.	The subject area was established as a Forest Reserve and later as a GMA and is presently considered by the department to be both. We therefore recommend that the designation as a GMA be recognized in the rules.
Unit E, PTA check-in, check-out times	3 letters, including 1 with 15 signatures attached, requested that Pohakuloa Training Area conform to state regulations regarding legal hunting hours. Comment: Recently PTA check-in and check-out times have been at the military's discretion, not as indicated in the State lease.	The department is reviewing its agreement with PTA for hunting in that area and expects to clarify conditions for use through discussions and a revised agreement.
Unit F additions	3 letters, including one with 15 attached signatures, stated agreement with the addition of Puu Waawaa Forest Reserve and Puu Anahulu GMA, West Section, and supported youth and disabled archery hunts there. At least 2 other letters expressed support for the youth hunt among comments on other hunting areas. Comment: I am for the youth hunt on the other side, Puu Lani side. Hopefully you guys can keep that really well managed.	Department concurs
	1 person wrote that they would like the entire area, Puu Waawaa Mauka and Makai to be labeled a GMA and opposed use of rifle in Unit F. Comment: This should be GMA and not a Forest Reserve because the area is a hunting area and changing the wording to GMA will require the DLNR to manage the area for hunting and conservation.	Although the PWW FR is designated as a FR, the department intends to manage PWW FR and PAH GMA for game production and sustainable yield, has secured authorization under the federal endangered species act to do so, and is seeking authorization under state laws to do so.
Unit F: Puu Waawaa Mauka	6 letters, including 1 with 15 attached signatures, commented on the lack of clarity in the Mauka rules or asked specifically that the Mauka area be opened: Comment: If the Mauka portion is not added for the general archery season, the area cannot be opened for hunting per section 123-4. Comment: Page 75 does not mention the Mauka areas, only Makai. The Mauka area rules need to be stated and clarified. Comment: I am extremely upset that the Puu Waawaa mauka area is no longer open for hunting, for years now. It seems to be multi-use, I see hikers and runners in there. That is a hunting area and it should be opened. Comment: Why is Puu Waawaa Mauka not slated to be opened at all in your new rules, when it used to be open for archery season and bird season? Comment: I request that the mauka section be added for the general archery season even at a limited capacity.	Mauka is proposed to be open for youth and disabled hunt in the puu lani safety zone. The department does not recommend that Puu Waawaa Mauka be opened for regular hunts at the present time in order to allow game to increase in that area. The area will be opened by permit once the population can support the hunt.
Unit F daily hunter limit	4 letters, including one with 15 attached signatures, questioned the 15 hunter per day limit and requested clarification. 1 person directly opposed a hunter limit: This area should not have a cap on the number of hunters. The place is known for big trophy goats and most of us drive from far distances to hunt here. Taking the chance, driving from Hilo and being denied entry because 15 people were already permitted to enter is crazy! Even reserving spots doesn't work because many people will reserve spots and not show up. Comment: The proper number of hunters allowed per day for special youth and disabled archery, general archery, and muzzleloader hunts needs to be clarified and listed for safety reasons and to maximize area use by public hunters. Comment: Is the 15 hunter limit for the youth hunt, or each area, or all areas combined? If the latter it seems like a small number of hunters for the size of the areas.	The department concurs and recommends that the limit be removed from the rules.
	Comment: The allowed limited number of hunters per day would not be needed if 13-123-4(b) [allowing the department to add conditions and restrictions for hunts, etc.] is allowed to remain in the present rules.	See Exhibit 1, Item 5

Unit F hunting days	1 comment supported daily hunting vs. weekend/holidays only.	The department recommends that hunting in unit F be weekends and holidays only for the purpose of managing a sustainable level of game in that unit. We appreciate that levels of game may at times increase and warrant additional harvest days. In those cases, the department will issue special hunt permits to allow more hunting opportunities.
Unit G Kaohe, allowing firearms	16 recorded comments and letters, including one with 15 signatures attached and one with 9 names typed at the bottom, opposed changing Unit G from archery only; 1 letter supported adding only muzzleloaders, and 2 supported adding a special muzzleloader or handgun season (but no rifles). The major objections were safety (use of firearms in the area is a safety risk because of non-hunters not wearing hunter orange, bisecting access roads, proximity to Saddle Road) and the popularity of Kaohe as an archery-only site with good concealment and a high number of animals that is open daily. Additional concerns were that allowing in firearms would essentially eliminate this as an archery site. Comment: Designating this area for rifle would necessitate the use of blaze orange garments. Camouflage is necessary for success in an already challenging means of taking game.	The department concurs that the use of rifles for public hunting in this unit is not desirable but notes that the area is within Palila critical habitat and therefore subject to the Palila court orders. The department recommends that the unit be archery, muzzleloader, and shotgun with slug only. Feral animal control for compliance with the court orders will be accomplished using staff and public hunters by special permit throughout the year.
	Comment: I would rather we work on expanding the mammal population in other areas and open new areas, if possible, instead of splitting resources or having to choose between gun hunters and archery hunters. Comment: 90% of the public hunting is opened up to rifle, muzzleloading, and archery and there's less than 1% that's opened to only archery, and I have really strong feelings about turning that area over to the firearm hunters.	The department concurs that the use of rifles for public hunting in this unit is not desirable but notes that the area is within Palila critical habitat and therefore subject to the Palila court orders. The department recommends that the unit be archery, muzzleloader, and shotgun with slug only. Feral animal control for compliance with the court orders will be accomplished using staff and public hunters by special permit throughout the year.
	Comment: The unit's dense foliage and hilly terrain, as well being located too close to Saddle Road is most definitely going to get someone killed. I see similar issues on the other outer islands.	The department concurs that the use of rifles for public hunting in this unit is not desirable but notes that the area is within Palila critical habitat and therefore subject to the Palila court orders. The department recommends that the unit be archery, muzzleloader, and shotgun with slug only. Feral animal control for compliance with the court orders will be accomplished using staff and public hunters by special permit throughout the year.
	2 comments suggested having special lottery hunts or short seasons allowing handguns and muzzleloaders to be used if game populations exceed the carrying capacity of Kaohe GMA. Comment: I am not opposed to using muzzleloaders in Unit G and would like to see a seasonal open hunting period implemented on a yearly basis. Muzzleloading hunting is just as difficult as bow and arrow because it has to be loaded from the barrel and there is only one shot. The sabot travels only a short distance compared to a rifle or handgun.	The department concurs and recommends that the rules be amended to specify archery only from September through June, muzzle loaders from July through August, and feral animal control using staff and public hunters by special permit throughout the year.
	Comment: Since we have lost so much archery-only acreage within the last year (PTA and now Kaohe), perhaps DLNR should mitigate this by finding new appropriate archery-only hunting areas.	See Exhibit 1, Item 19
	Comment: This change would eliminate my ability to hunt an archery only area. Many hunters need to work weekends and holidays. The change would also lead to more overcrowding in the remaining archery only areas that are open weekends and holidays.	The department concurs and recommends that the rules be amended to specify archery only from September through June, muzzle loaders from July through August, and feral animal control using staff and public hunters by special permit throughout the year.
Unit G pig hunting season	3 letters, one with 15 attached signatures, opposed year-round hunting for pigs. Comment: The Sierra Club lawsuit against the State of Hawaii included only sheep and goats. Since pigs were not mentioned in the lawsuit, Kaohe pigs should be managed for game and limited to one per day per hunter, and the season July-December	Department concurs and recommends a limit of one pig per hunter per day.
Unit G bag limits	1 letter opposed not having bag limits for Units G, E, and K, specifically for sheep and goats.	See Exhibit 1, Item 1
Unit H checkout time	1 person wrote that the 4:30 checkout notation shown for the Kulani Buffer zone was established when there was an adjacent active prison. With the prison now closed, it should be deleted.	The future of the former prison remains in question and discussions suggest that it may resume its former use. Department recommends the 4:30 time remain until the use of the site is determined.
Unit H hunting days	1 comment supported daily hunting vs. weekend/holidays only.	See Exhibit 1, Item 1
Unit I hunting days	1 comment supported daily hunting vs. weekend/holidays only.	See Exhibit 1, Item 1
Unit J, removal of GMA designation	5 recorded comments and letters, one with 15 attached signatures, opposed the change: Unit J should remain a GMA and should include Kapapala Cooperative GMA. Comment: I support sustained hunting so feel the designation GMA should remain. Comment: I feel the wording GMA must remain to protect management control by means of public hunters to be protected by rule of law. I support sustained hunting in this area as an absolute right to the citizens of Hawaii. Comment: It should remain a hunting area, I oppose any closing.	The purpose of the J designation is to identify cooperative game management areas, which are, by definition, private lands or leased lands for which the department has established agreements to provide access and opportunities for public hunting. Kapapala GMA is still a unit J GMA for bird hunting but no agreement with the landowner exists for mammal hunting. The former units at PWW and PAH are no longer unit J since they are now state lands managed by the department as FR and GMA. The former Kaohe lease has been set aside as mitigation for the saddle road realignment pursuant to an agreement under the federal ESA.
