We are pleased to inform you that your Conservation District Use Application for a classroom building was approved on April 12, 1990, subject to the following conditions:

1. The applicant shall comply with all applicable statutes, ordinances, rules and regulations of the Federal, State and County governments, and applicable parts of Section 13-2-21, Administrative Rules, as amended.
2. If historic remains such as artifacts, shell or charcoal deposits, burials, and stone pavings are found during construction, the applicant must stop work in the area and contact the Historic Preservation Program (at 548-7460), immediately; that office is authorized to assess the situation and make recommendations for mitigative action, if needed.
3. Before proceeding with any work authorized by the Board, the applicant shall submit four (4) copies of construction and landscaping plans, and specifications, to the Chairperson or his authorized representative for approval for consistency with the conditions of this permit and the

declarations set forth in the permit application. Three (3) approved copies are to be returned to the applicant; plan approval by the Chairperson (or authorized representative) is not to imply approval required of other agencies.

4. The applicant is required to use only such paint and landscaping material as may be acceptable to this Department, to be installed according to plans submitted to this Department for approval.
5. Appropriate measures shall be exercised to prevent construction materials, debris, petroleum derivatives, etc., from entering or polluting the surrounding area; upon the completion of construction, all debris, materials and equipment shall be removed.
6. Any work to be done on the land shall be initiated within one (1) year of the approval of such use, and all work and construction must be completed within three (3) years of the approval of such use.
7. The use of the property is limited to those articulated in the application.
8. Failure to comply with any of these conditions shall render this Conservation District Use Application null and void; and
9. Approval is subject to other terms and conditions as may be prescribed by the Chairperson.




