Summary Paragraph

The Ronald Kamehameha o ka hae Hawaii von Holt residence is a 2.7 acre oceanfront property on the West coast of the Big Island. The property was purchased in 1936 and most of the improvements were completed by 1938. The residence has been in continuous use as a family beach cottage. It has been in the same family since 1936. It was designed by architect Albert Ely Ives. The property is isolated and surrounded by lava fields.

 The property consists of three buildings and two water

 storage tanks. The main house, the sleeping house, and

 the water storage tanks were the original buildings.

Recently, a storage building was built to resemble the unique architecture of the original buildings. All buildings are constructed with exterior walls of lava rock and coral and low pitch hip roofs. The water tank roofs are flat. They all have flat concrete foundations. The main house is completely open concept with glass windows on all sides. The house was designed to open on both the West (Oceanside) and East to allow airflow through the house. The sleeping house consists of three bedrooms. Wooden walls were built as the interior room separators.

Except for the modernization of solar electricity through solar roof panels, all historical buildings maintain their original appearance.

The two water tanks were designed to hold water for domestic use. The upper tank stores brackish water which is pumped from the ponds below. It is then stored, and gravity fed to the house for use. The lower tank stores fresh water which is catchment from the rain off the roof of the main house. Currently this water is pumped into the main house for domestic use. There are three connected Anchialine fish ponds that surround the house. Ronald restored the ponds to raise mullet.





The Ronald Kamehameha o ka hae Hawaii von Holt residence has historical significance for several reasons. The unique design and construction of the buildings in 1938, the life of Ronald Kamehameha o ka hae Hawaii von Holt, and the restored Hawaiian fish ponds.

First, the property is significant as an example of a 1930's Kona Coast beach cottage. The architecture of solid interior/exterior walls has proven to withstand

Secondly, the builder of the house was Alexander Ronald Kamehemeha o ka hae Hawaii von Holt. He was commonly called Ronald by all. Ronald was a prominent cattle rancher running the Kahua Ranch in Waimea from 1928 until his death in 1953. He was born on August 11, 1898, the day before the American flag was raised over the islands. His middle name (o ka hae Hawaii) is historically significant as it translates to "the last child born under the Hawaiian flag". There is a plaque in his honor on state route 250, the road to access Kahua Ranch. Ronald used cowboys (paniolos) from Kahua Ranch as laborers during construction. Another historical feature of this property are the restored Anchiline fish ponds. Hawaiians used these natural brackish ponds to stock fish and raise them to a good eating size. The brackish water also supports opae ula (small red shrimp) that are still prevalent in the ponds today. The ponds originally had a Makaha, or opening to the ocean, that the Hawaiians built and would use to help control the fish traffic. Unfortunately, this Makaha was covered up in the Tsunamis of 1946 and 1960.
