# Aloha i ke Kai

HAWAI'I OCEAN STEWARDSHIP FEE PROGRAM

Aloha i ke Kai - the Hawai'i Ocean Stewardship Fee Program is a sustainable funding solution led by the Department of Land and Natural Resources (DLNR), Division of Aquatic Resources (DAR) to support marine stewardship initiatives via direct investment from ocean users. Pursuant to Act 46 (2021), in January 2024 the DLNR-DAR began collecting \$1 per ocean user participating in a commercial ocean recreation activities. DLNR-DAR anticipates between two and three million dollars of annual revenue generated for diverse marine stewardship projects.



**Fee Collection** - All ocean activity commercial operators charge customers and passengers a \$1 ocean stewardship fee. This fee is then transferred to the DLNR-DAR via an online payment portal. Ocean activities include underwater experiences (such as snorkel, SCUBA, and Manta Ray tours), on-ocean experiences (such as whale watching, catamaran cruises, fishing charters and dinner cruises), and on-water craft experiences (such as surfing, jet-skis, and guided kayak tours).

#### Aloha i ke Kai Spend Plan

The Aloha i ke Kai program intends to catalyze long term funding commitments to support local stewardship and conservation practices that benefit ocean users and Hawai'i communities. These funds will support ongoing DLNR-DAR projects and new initiatives associated with Aloha i ke Kai. The spend plan pie chart to the right lists intended project allocations:

- 25% Statewide Day Use Mooring Buoy
- 20% Community Stewardship
- 20% Coral Reef Restoration
- 10% Improving Coastal Water Quality
- 10% Education and Outreach
- 5% Marine Invasive Species Management
- 5% Commercial Operator Stewardship
- 5% Marine Debris Prevention, Response, and Mitigation





## Revenue Generated to Date: \$1,501,335.00


January 2024 - August 2024


