 - (2) The registered owner has pending a citation for violation of any of the department's rules; or
 - (3) The registered owner's vessel is an abandoned vessel, grounded vessel, derelict vessel, unauthorized vessel, or vessel impounded under section 200-16.

WARRANTIES/APPURTENANCES/LIMITATIONS/EXCEPTIONS

Any moneys due and payable to DLNR, pending citations and notices of impound should be stated here.

If there is a balance due or the vessel is deemed grounded, derelict or unauthorized according to definitions found in the HRS or HAR, the vessel registration will not be transferred between parties by DLNR.
