- **The original vessel title must be submitted to DOBOR along with this form before a replacement title will be issued, unless the original vessel title is lost, stolen, or destroyed.**
- **If the original vessel title is mutilated, the original title must be submitted to DOBOR, regardless of its condition.**
- **If the original vessel title is lost or stolen, the owner or secured party is responsible for submitting the original vessel title if it is later found or returns to the owner's/secured party's possession.**
- **Once a replacement title is issued, all previous vessel titles are void and cannot be used to transfer ownership of the vessel named therein.**
- **Replacement titles will only be given or mailed to an owner of record or secured party of record.**
