There are no lifeguards inmost State Parks areas. Swimming, wading and other water activities shall be at your own risk.

Do not leave valuables unattended. Lock your car. Do not leave valuables even in locked cars.

Persons should use good judgment while using the parks and facilities. Security service is not provided.

Permits may not be transferred.

Permits shall be revoked for violation of park rules, permit conditions. Or any applicable law.

Permittee shall obtain all permits from other government agencies as may be required.

Not be permitted to bring any pets or animals except service animals as defined by the Department of Justice under the Americans With Disabilities Act, providing their service duties, into the Park.

Animals are prohibited in swimming areas and beaches. Animals are also prohibited in parks or park areas where signs are posted prohibiting animals, except for see-eye dogs. Where not prohibited, animals must be crated, caged or on a leash or otherwise under physical restrictive control at all times. Persons responsible for animals are responsible for cleanup/disposal animal droppings and for damages caused by animals. Horseback riding is not allowed except in areas designated for horseback riding by appropriate signs.

Smoking and the use of tobacco products and electronic smoking devices is prohibited in state parks. Permittee shall be responsible for clean-up of the area used. Permittee shall be liable for repair, replacement or payment for any damages.

Campers named on this permit may not camp at the same park within 30 days of the dates on this permit.

Lodgers named on this permit may not use lodging facilities at the same park within 30 days of the dates on this permit.

The permittee waives any and all claims he may have against the State of Hawaii and its respective officers, agents and employees, and agrees to defend, hold harmless and indemnify the State of Hawaii and its respective officers, agents and employees, from any suits, actions and claims arising out of or in any way connected with the activities permitted under the permit. Permittee shall comply with other conditions that may be imposed by the Department. Where these provisions conflict with the Special Conditions of the permit, the Special Conditions shall prevail.

NAMES AND IDENTIFICATION (ID) NUMBER REQUIRED

Names and ID numbers of all persons 18 years & older must be listed on camping & lodging (cabin) permits. Acceptable ID numbers include Driver License, Social Security, State ID, Passport or other foreign ID. Permittee shall show the permit (and I. D. if applicable) to any authorized personnel upon request at the park.

ALL PERSONS COVERED BY THIS PERMIT SHALL NOT:

• Park vehicles except on roads and parking areas laid out, designated, or provided for public parking.

• Build fires except in designated fireplace or grills.

• Dump live coals except in designated ash pits or receptacles.

• Dispose of garbage, paper trash or rubbish of any kind except in places designated for rubbish disposal.

• Wash clothes or articles of household use in open shower area or restrooms.

• Use obscene or objectionable language.

• Use, drink, display or possess alcoholic beverages or illegal drugs.

• Operate or use any audio devise or musical instrument in such a manner and at such times so as to create excessive noise or nuisance.

• Swim, sunbathe, take outdoor showers, walk or remain in the nude.

• Destroy, damage, dig, remove or possess any tree, shrub, or other plant.

• Take, possess, damage, remove, excavate, disfigure, deface, or destroy any park facility or objects of antiquity, prehistoric ruins and monuments.

• Nail, tack or staple articles on buildings or structures.

• Remove furnishings from buildings.

Use or possess fireworks, firecrackers, explosives, firearms and other weapons except as authorized by proper authorities.

Obstruct or unreasonably interfere with the general public in their normal use of the park.
