VESSEL SPECIAL USE PERMIT 2025-2026
NON-COMMERCIAL APPLICATION FORM INSTRUCTIONS

1. PERMIT STATUS
 - Place a “√” in the box. First time = New
2. PERMITTEE
 - Name of the person as shown on official identification.
3. VESSEL NAME
 - If Applicable. (Usually boats or canoes.)
4. REGISTRATION#
 - If Applicable (Usually starts with HA and six numbers or letters after.)
5. VESSEL DOCUMENT TYPE
 - U.S. Coast Guard certified? (boats)
6. VESSEL TYPE
 - 1 application form for each type of vessel.**
 - BOAT
 - Catamaran, Power
 - CANOE
 - Outrigger, Double Hull
 - INFLATABLE
 - Rigid Hulled Inflatable Boat, air filled vessels
 - KAYAK
 - All types including Inflatable
 - PADDLEBOARD
 - Stand-up, kneeling
7. VESSEL DOCUMENT#
 - All numbers.
8. OVERALL VESSEL LENGTH
 - In feet and inches.
9. VESSEL PASSENGER CAPACITY
 - The total number of people the vessel can hold.
10. TOTAL# OF VESSELS
 - The number of vessel(s).
- MAILING ADDRESS
 - Address you want postal mail addressed to.
- PHONE #
 - Home telephone number.
- MOBILE #
 - Mobile cell phone number.
- MOBILE ACCEPTS TEXT
 - “√” if mobile phone accepts text.
- EMAIL ADDRESS
 - Enter Permittee's e-mail address.
- EMERGENCY CONTACT NAME
 - Enter in a contact name for emergencies.
- EMERGENCY PHONE NUMBER
 - Enter telephone number of emergency contact.
- EMERGENCY MOBILE #
 - Enter mobile cell phone number of emergency contact.
- ORGANIZATION NAME
 - Non-Commercial organization name.
- ORGANIZATION CONTACT NAME
 - Contact name of organization.
- ALTERNATE CONTACT NAME
 - Enter in an alternate contact name for emergencies.
- PERMITTEE SIGNATURE
 - The Permittee signs name or types it in.
- DATE
 - Enter in the date you are submitting application form.
- EMAIL APPLICATION
 - Email application to **KBSHP.VESSEL.SUP@hawaii.gov**
