HRS § 184-4.2 Registration required for rental vessels; registration number; fees. Every rental vessel rented or leased, or offered for rent or lease, to the public for transiting the navigable waters of a state park shall have a registration number affixed to the rental vessel.

1. The Permittee shall comply with all federal and state laws and the rules of the Department of Land and Natural Resources ("DLNR") and adhere to all safety signs posted on the Premises. Any violation of these laws and regulations may result in immediate suspension of this permit and the permittee may be subject to civil and criminal penalties.
2. Permittee must be a duly organized business in good standing in the State of Hawai'i throughout the terms of the permit.
3. Permittee must hold a current Hawai'i General Excise Tax license.
4. Permittee must hold a current Hawai'i State tax clearance certificate.
5. Guided tours require a separate special use permit. No guided tours allowed unless authorized by a separate DLNR Special Use Permit.
6. Permit does not allow delivery of rental vessels to any Park unit by the permittee.
7. Limit commercial rentals accessing Wailua River State Park, Kealakekua Bay State Historical Park and Ahupua'a 'O Kahana State Park to Monday through Friday during Park Hours only.
8. Ensure that each rental vessel be identified by a unique number, assigned by State Parks.
9. Decal shall be affixed to the rear of the rental vessel.
10. Fee for the registration and numbering of a rental vessel is seventy-five dollars (\$75.00) per vessel per annum.
11. Permittee shall not rent vessels if a flood advisory, flash flood warning or flash flood watch issued by the National Weather Service is in effect for the park area in question.
12. This permit does not authorize business operation related to soliciting for customers, renting equipment or otherwise promoting a business within Wailua River State Park, Kealakekua Bay State Historical Park and Ahupua'a 'O Kahana State Park. Doing so is in violation of the following:
  - a. HAR §13-146-66 Business operations. No person shall engage in or solicit any business, except in accordance with the provisions of a permit contract, license, lease, concession, or other written agreement with the Board or its authorized representative, or as allowed by HAR Chapter 13-7
  - b. HAR §13-146-68 Commercial activities. No person shall engage in commercial activities of any kind, without a written permit from the board (Board of Land and Natural Resources) or its authorized representative.
13. This permit shall be revoked if these conditions are not followed.
  - a. HAR §13-146-50(d)(3) Permits may be cancelled or terminated at any time without advance notice when: Permittee's violate permit conditions or provisions of this chapter.
