Executive Order No. _ 3162

Setting Aside Land for Public Purposes

By this Executive Order, I, the undersigned, Covernor of the State of Hawaii, by virtue of the authority in me vested by Section 171-11, Hawaii Revised Statutes, and every other authority me hereunto enabling, do hereby order that the public land hereinafter described be, and the same is, hereby set aside for the following public purposes:

FOR NATURAL AREA RESERVE, to be under the control and management of the Department of Land and Natural Resources, State of Hawaii, being the lands situate at Keawaula, Waianae, Island of Oahu, State of Hawaii, and designated as KAENA POINT NATURAL AREA RESERVE, consisting of two parcels of land:

PART 1, containing an area of 12.0 Acres, more or less,

PART 2, containing an area of 0.464 Acre, more or less,

All more particularly described in Exhibit "A" and delineated on Exhibit "B", both of which are attached hereto and made a part hereof, said exhibits being, respectively, a survey description and survey map prepared by the Survey Division, Department of Accounting and General Services, State of Hawaii, both being designated C.S.F. No. 18,641 and dated May 4, 1979.

SUBJECT to disapproval by the Legislature by two-thirds vote of either the Senate or the House of Representatives or by majority vote of both, in any regular or special session next following the date of this Executive Order.

- 7. 235° 00' 242.80 feet along United States Coast Guard Lighthouse Service Lot to the point of beginning and containing an AREA OF 12.0 ACRES, MORE OR LESS.

Beginning at the east corner of this parcel of land, on the northwest boundary of United States Coast Guard Lighthouse Service Lot and on the boundary between the lands of Kaena and Keawaula, the direct azimuth and distance from Government Survey Triangulation Station "KAENA POINT U.S.E." being 106° 05' 106.90 feet, thence running by azimuths measured clockwise from True South:-

- 1. 55° 00' 233.50 feet along United States Coast Guard Light-house Service Lot to highwater mark at seashore;
- Thence along highwater mark at seashore, the direct azimuth and distance being:

164° 07' 50" 214.12 feet;





FOR ADDITION TO THE KAENA POINT NATURAL AREA RESERVE, to be under the control and management of the Department of Land and Natural Resources, Division of Forestry and Wildlife, Natural Area Reserve System, being that parcel of land situate at Kaena, Waialua, Oahu, Hawaii, identified as "Addition to Kaena Point Natural Area Reserve System, Parcel 7," containing an area of 0.24 acre, more or less, TOGETHER with Easement 5, more particularly described in Exhibit "A" and delineated on Exhibit "B," both of which are attached hereto and made parts hereof, said exhibits being respectively, a survey description and survey map prepared by the Survey Division, Department of Accounting and General Services, State of Hawaii, both being designated C.S.F. No. 23,912 and dated November 19, 2004.

SUBJECT, HOWEVER, to the condition that upon cancellation of this executive order or in the event of non-use or abandonment of the premises or any portion thereof for a continuous period of one (1) year, or for any reason whatsoever, the Department of Land and Natural Resources, Division of Forestry and Wildlife, Natural Area Reserve System, shall, within a reasonable time, restore the premises to a condition satisfactory and acceptable to the Department of Land and Natural Resources, State of Hawaii.

SUBJECT, FURTHER, to disapproval by the Legislature by two-thirds vote of either the Senate or the House of Representatives or by majority vote of both, in any regular or special session next following the date of this Executive Order.
