

Setting Aside Land for Public Purposes

By this Executive Order, I, the undersigned, Governor of the State of Hawaii, by virtue of the authority in me vested by Section 171-11, Hawaii Revised Statutes, and every other authority me hereunto enabling, do hereby order that the public land hereinafter described be, and the same is, hereby set aside for the following public purposes:

FOR NATURAL AREA RESERVE, to be under the control and management of the Department of Land and Natural Resources, State of Hawaii, being the land situate at Waimea, Kauai, Hawaii, and designated as KUIA NATURAL AREA RESERVE, containing an area of 1,636 Acres, more or less, more particularly described in Exhibit "A" and delineated on Exhibit "B", both of which are attached hereto and made a part hereof, said exhibits being, respectively, a survey description and survey map prepared by the Survey Division, Department of Accounting and General Services, State of Hawaii, both being designated C.S.F. No. 18,817 and dated January 11, 1980.

SUBJECT to disapproval by the Legislature by two-thirds vote of either the Senate or the House of Representatives or by majority vote of both, in any regular or special session next following the date of this Executive Order.

KUIA NATURAL AREA RESERVE

Waimea, Kauai, Hawaii

Being portion of the Government (Crown) Land of Waimea.

Beginning at the east corner of this parcel of land at a point on the 3920-foot elevation near the west side of Kokee Road;

Thence southwesterly along Kaunuohua Ridge to a point on the 3720-foot elevation near the southwest corner of the Kokee Instrumentation Station;

Thence westerly down the middle of Mahanaloa Valley to a point near the 2560-foot elevation;

Thence in a southwest direction for a distance of approximately 1100 feet, more or less, to a point on the middle of Paaiki Valley on the 2520-foot elevation;

Thence in a northwesterly direction for a distance of approximately 2700 feet, more or less, to a point on the 2400-foot elevation;

Thence in a northerly direction and crossing the Paaiki Valley for a distance of approximately 1500 feet, more or less, to a point at the peak having a 2262-foot elevation;

Thence in a northeasterly direction and crossing Kuia, Poopooiki and Kawaiula Valleys for a distance of approximately 10400 feet, more or less, to a point on the middle of Nualolo Valley near the 2680-foot elevation;


Thence southeasterly up along the middle of Nualolo Valley, to the point of beginning and containing an AREA OF 1,636 ACRES, MORE OR LESS.

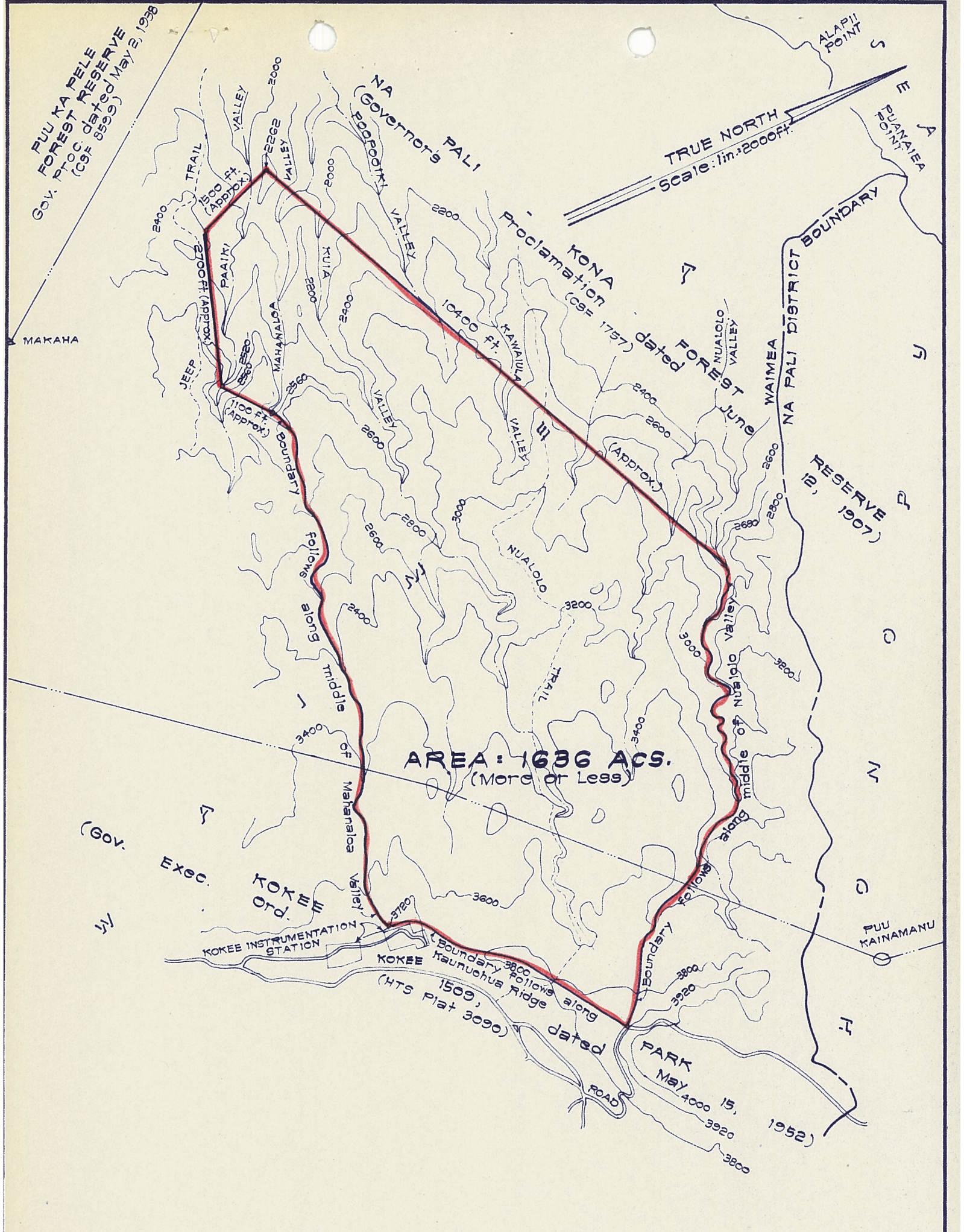
