ITEM 1. Call to order, introductions of members, staff and others.

Jonathan Price (NARSC) chaired the meeting.

ITEM 2. Review allocation history and future budget requests covered under Act 84:

Emma Yuen, Native Ecosystem Protection and Management (NEPM) Program Manager provided an overview of funding history and allocation of funds now covered under Act 84. She provided a summary of total funding for LNR 407 (previously the Natural Area Reserves Fund) from FY14-FY19 as well as the FY20 allocation of \$11,125,014 funding between LNR 407 and LNR 402 programs (see attachments #1 and #2).

Irene Sprecher, Forestry Program Manager provided an overview of LNR 172 FY20 Budget Allocation (see attachments #3 and #4).

ITEM 3. Natural Area Partnership Program (NAPP) review and new projects:

Emma Yuen provided an overview of the NAPP funds and allocation. Maui County currently gets the bulk of the NAPP funding, as well as a large portion of the Watershed Partnership Program grant funding. Emma also provided an overview of Capital Improvement Project funding used for Watershed Partnership fencing projects.

ITEM 4. Forest Stewardship Program (FSP) review and new projects:

Tanya Rubenstein, Cooperative Resource Management Forester provided an overview of FSP project funding, current projects and new initiatives (see attachments #5 and #6). DOFAW is looking at new initiatives related to large scale reforestation of pasture on stateleased lands including native timber projects such as Paniolo Tonewoods with koa reforestation.

ITEM 5: Carbon sequestration projects and large-scale forest restoration plans:

Irene Sprecher provided an overview of the status of recent DOFAW Carbon Initiatives. DOFAW currently has two trial projects at Puu Mali and Kahikinui Forest Reserve/Nakula Natural Area Reserve, both focused on reforestation. Pono Pacific will be developing the Puu Mali project and DOFAW is working on the Kahikinui project. For Kahikinui, DOFAW selected Verra, as an independent carbon standard and TerraCarbon as the project developer to help with the certification process. The forest carbon certification (registration and verification) is estimated to cost approximately \$150,000. DOFAW is designing the project as a grouped project to permit reforestation activities on additional properties to be added to the project after it is initially registered. The Nature Conservancy of Hawaii is working on projects related to improved forest management (at Kona Hema Preserve).

ITEM 6. Summary of other programs that received funds:

Emma Yuen provided information on other programs. These programs include Youth Conservation Corps (YCC), Watershed Partnership Program (WPP), Hawaii Invasive Species Council (HISC), Natural Area Reserves System (NARS), Forest Reserve System (FRS), Rare Species Programs, Information and Education, and Legacy Land Commission. There is a large effort to achieve the 30 x 30 watershed initiative goals by fencing and protecting additional priority watersheds.

ITEM 7. Budget review and discussion.

Michael Constantinides requested meeting materials and suggested DOFAW consider overall objectives and associated issues (e.g. pros/cons, alternatives, concerns etc.) to allow FSAC and NARSC members to provide the most meaningful and beneficial input.

Olu Campbell offered potential assistance with other federal funding sources through Department of Education and Department of Defense, as well as the Congressional Delegation. The group discussed the issue of ordnance removal at Ilio Point on Molokai, as a potential item needing follow-up assistance with.



LNR172 FY20 Budget Allocations - Breakouts





- Since 1990, the Forest Stewardship Program has helped **65 private landowners sustainably** manage **36,778** acres of forested lands (3% of private lands in the state)
- 14 projects with cost-share agreements implementing management plans (see attached)
- 19 projects with approved plans with 7 of these seeking cost share support for implementation from FSP and the others implementing plans through alternative funding sources.
- 32 projects in post 10-year maintenance phase
- The Department has used \$5,235,008 in state funds for conducting forest management activities under 10-year FSP agreements with \$6,989,575 in private funds as a direct match.
- U.S. Federal Forest Service funding \$1,196,850 to support the program since 1990
