**APPLICATION FOR COMMERCIAL USE OF
HAWAIIAN THREATENED AND ENDANGERED PLANT SPECIES
Hawaii Administrative Rules Chapter 107**

This application is for Department of Land and Natural Resources (DLNR) approval of commercial use of Threatened and Endangered plants. “Commercial use” is defined as the transfer of a plant for a fee, charge, or other compensation. Plants may only be sold if accompanied by a tag provided by DLNR. When approved, tags issued under this application must only be used for the plants listed in this document. The tag informs DLNR, vendors, and customers that each plant is approved for commercial use and was sourced from garden-grown stock and not from a wild population.

Applications can be emailed to Matthew.J.Keir@hawaii.gov or mailed to: State Botanist, Division of Forestry and Wildlife, Department of Land and Natural Resources, 1151 Punchbowl Street Room 325, Honolulu, Hawaii 96813 and may take up to 30 business days to be processed. Each tag is \$0.10. We will contact you at the email address you enter below when the tags are ready to be picked up. To receive the tags by mail, please provide an additional \$5.00 to cover the cost of shipping. 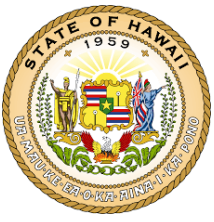

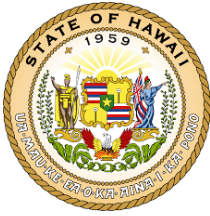

Special Conditions:

- A. All Threatened or Endangered plants approved for commercial use must be certified to have been obtained from a garden-grown source to prevent impacts to the remaining wild populations.
- B. All T&E plant species in the commercial trade that are sold, given away, or donated should be properly tagged with the following information: scientific name, source of origin.
- C. The permit holder shall allow the Administrator's authorized representatives to enter the premises of the Permit Holder at any reasonable hour to inspect any plant held or to inspect, audit, or copy any permits, books, or records required to be kept by the Permit Holder.
§13-104-2 Definitions.
"Administrator" means the administrator of the division of forestry and wildlife.
"Authorized representative" means the administrator, foresters, conservation enforcement officers, and other persons authorized by the board of land and natural resources to act for the board.
- D. The permit holder will keep records of the species name, date and number of propagules/plants sold, given away, or donated. This information will be available for inspection at any time upon request by an authorized representative of the department authorized by the board to act for the board.

I certify that none of these plants or propagules listed above were taken or collected from wild plants or their populations and that I have read the special conditions listed above, understand them, and agree to abide by them.
