- Introduction and project overview by Dr. Leyla Kaufman, Project Coordinator for Māmalu Poepoe interagency airports monitoring project (see PPT presentation for details).
 - a. David Rodriguez: Kahului/OGG not an international airport. Please correct.
 - b. Richard Onishi: How were target species selected and will others be identified and added?
 - i. Darcy Oishi: Africanized Honeybees were identified because HDOA regularly sees honeybees at the airports. HDOA needs more traps within secured areas of the airports via this program. RIFA is not yet in Hawai'i. Potential to add other species in the future depending on the need. Proof-of-concept at this point. BTS is

specifically an HDOA-PQB responsibility and will have a canine team in operation soon for BTS-detection.

- 5. Review of recommended HISC grants budget for Fiscal Year 2017 (Josh Atwood & Justine Nihipali see PPT for details)
 - a. Review of application and evaluation process:
 - i. Richard Onishi: Question regarding HISC RCUH/PCSU staff overhead vs. DLNR/DOFAW civil service staff. Josh clarified that he is a civil service Wildlife Biologist with part of his duties being supervision of the HISC program. The other HISC Support positions are temporary RCUH positions.

 - i. Scott Enright: Why was ROD Genetics only recommended for ½ the requested funding?
 - 1. Josh Atwood: Applicant indicated he could identify another source for the remaining funding.
 - ii. Scott Enright: Was Kohala ROD Survey a DLNR ask?
 - 1. Josh Atwood: Yes, as part of the watershed program
 - iii. Submittal: Requesting approval of a recommended budget for HISC's support program and grants program in Fiscal Year 2017

 - 1. David Rodriguez: Motion to accept the recommended budget as submitted.

 - 1. Richard Onishi: Question regarding Rapid Ohia Death research funding. Legislature not receiving updates on ROD for what is needed.
 - a. Rob Hauff: ROD Working Group mostly informationfocused and not funding-focused. Requests submitted were representative of ROD Working Group research focus. Monthly ROD WG calls have been very effective and with a diverse representation.
 - b. Suzanne Case: Legislative updates would be good to provide.
 - c. Josh Atwood: ROD Working Group has Outreach committee that meets regularly and HISC can provide you with contact info and/or have them provide updates.
 - d. Scott Enright: Rep. Onishi's point is well-taken and am sure he will receive more information very soon. An informational meeting will be put together soon for the Legislature.
 - e. Keith Kawaoka: Are past projects available for review? And are regular reports required?
 - i. Josh Atwood: Yes. Past funded project abstracts and final reports are available on the HISC website by fiscal year.
