

- 2. Introductions

- 4. Submittal: Requesting approval of a recommended budget for Fiscal Year 2022
  - a. Discussion
    - i. Chelsea Arnott presented on the HISC budget process, proposal scoring process, Resources Working Group meeting on budget allocations, funding shortfalls, and a proposal to close the funding shortfall gap with altering the HISC Resources Working Group proposed proposal with additional funding
      - 1. Comments
        - a. David Smith provided comments on the importance of HISC program and the need for additional funding.

- b. David Rodriguez commented on the resources working group's open process for deciding the budget allowing for all groups.
- c. Rob Hauff commented on the restrictions of sunshine law and the length of the meeting.
- d. Rep. Lowen inquired about how the Big Island group was less funded.
- e. Chelsea clarified that the BIISC started with lower scoring proposals and a lower starting funding amount.
- f. Rep. Lowen suggests that the funding is commensurate to the size of the island and the problems it faces
- g. David Smith comments that different islands have different issues
- ii. Chelsea Arnott presented the Recommended Budget
  - 1. Proposals that are recommended to not fund
  - 2. Programmatic Awards
  - 3. Biocontrol Research and Weed Management
  - 4. Aquatics
  - 5. Rapid Ohia Death
  - 6. Research
  - 7. Mosquitoes
  - 8. Ungulates
  - 9. Recommendation is to:
    - a. That the HISC approve the FY22 budget for HISC support and an interagency project portfolio that is recommended by HISC Support Staff with the 2.5% reduction, and
    - b. That, should the Department of Budget and Finance make any changes to the restriction on expenditures, the HISC delegate authority to the HISC Support Staff to identify best way to apply additional restrictions to project funds, or to identify best uses of any released funds, and
    - c. That, if there are any changes in the scope or implementation of projects over the course of the year, the Council delegate authority to the HISC Support staff to make adjustments to project funds or reassign project funds from any project that does not proceed in a timely manner.

        - 1. Lori Buchanon (MoMISC) asks for the council to recommend extra meetings between the applicants and HISC staff before next years appropriations to improve the budgeting process.
        - 2. David Smith noted that a lot of important work was not funded which shows a need for more funding for HISC.
        - 3. Lindsey Nietmann (DOFAW) provided written testimony in support of funding the USDA-

APHIS project to conduct the research required to register a toxicant for mongoose control with the US Environmental Protection Agency (EPA) HISC funding application for the full amount requested.

Christy Martin (CGAPS) The \$6+ mil/year paid by sea cargo importers into HDOA's pest inspection & eradication fund was used to support nearly half of the 90 PQ inspectors, & critical support for HAL, BIISC, CTAHR research, etc. Can the Council and legislators meet to discuss if and how funds may be prioritized for this critical invasive species work instead of going directly into the general fund?
