RULES FOR PERSONAL COLLECTING IN THE FOREST RESERVE

1. This permit is subject to denial, cancellation, or termination at any time by DOFAW upon violation of HAR chapter 13-104 or any conditions of the permit or any federal, state, or county statutes, ordinances, or rules, or for danger to the public or because of natural causes.
2. This permit does not exclude the necessity for other associated permits that may be required from other Federal, State or County Agencies.
3. Provisions of Chapters 183, 185, and 195, Hawai'i Revised Statutes, 1985, as amended, and any other laws applicable thereto, and all rules and regulations of the Department of Land and Natural Resources shall be strictly observed. Infractions or misconduct will constitute grounds for revocation of this permit and criminal prosecution. Any person whose permit has been revoked shall not be eligible to apply for another permit until the expiration of two years from the date of revocation.
4. The Permittee(s) waive(s) any and all claims he/she may have against the State of Hawai'i and its respective officers, agents and employees, and agrees to hold harmless and indemnify the State of Hawai'i and its respective officers, agents and employees, from any suits, actions and claims arising out of or in any way connected with the activities allowed under this permit.
5. Persons in violation of the terms and conditions of this permit and/or related or appropriate laws may be subject to criminal and or administrative penalty under Hawai'i Revised Statutes §183-4, §183-5, §183-18, §183-21, §183C-7, §171-6.4 §171-31.6, Hawai'i Administrative Rules §13-104-3 or as otherwise provided by law.
6. Application, once embossed, becomes official collection permit.
