TMT INTERNATIONAL OBSERVATORY, LLC'S MEMORANDUM IN OPPOSITION TO TEMPLE OF LONO MOTION TO STRIKE FOR FAILURE TO SERVE OR EXTENSION OF TIME AND RESCHEDULING OF HEARING FILED OCTOBER 12, 2016

COMES NOW, TMT International Observatory, LLC ("TIO"), by and through its counsel, Watanabe Ing LLP, and hereby submits this Memorandum in Opposition to Temple of Lono ("TOL") Motion to Strike for Failure to Serve or Extension of Time and Rescheduling of

Hearing, filed October 12, 2016 ("Motion to Strike"). The Motion to Strike should be denied, inasmuch as TIO timely filed its pleadings and timely served those pleadings upon all parties to this proceeding.

I. DISCUSSION

In its Motion to Strike, TOL argues that TIO's pleadings should be stricken because TIO failed to serve copies of the pleadings on some of the parties. TOL, however, is mistaken. TIO timely filed its pleadings, and timely served all parties in this proceeding.

Pursuant to the deadlines set forth by the Hearing Officer, TIO filed its Final Witness List and Written Direct Testimony of Witnesses, Pre-Hearing Statement, and Exhibit List and Exhibits 1 to 34 on October 11, 2016. The time-stamped copies of each of these pleadings illustrates that they were filed at 3:48 pm, 3:48 pm, and 3:49 pm, respectively, on October 11, 2016. See Exhibits 1, 2, 3, attached hereto.

On October 11, 2016, at 4:56 pm, via email correspondence, TIO served copies of the pleadings upon all parties to this proceeding. See Exhibit 4, attached hereto; Declaration of Ross Shinyama, attached hereto. In that email correspondence, Ellen Yamamoto of the law firm of Watanabe Ing LLP provided a link to each of the parties in this proceeding, which allowed those parties to download the pleadings. Note that the email address of TOL's counsel, lanny.sinkin@gmail.com, is clearly included in this email correspondence. Several of the parties downloaded the documents using the email link, indicating that the email correspondence had been received and the link operational. There was no bounce-back message indicating that this email correspondence failed to reach any of the listed recipients, including TOL's counsel, at lanny.sinkin@gmail.com.

Additionally, Michael Cain of the Board of Land and Natural Resources accessed the pleadings via the email link provided by Ellen Yamamoto on October 11, 2016. See Exhibit 6. Mr. Cain then placed TIO's pleadings on the DLNR website, so that all of the parties could access the documents. Accordingly, DLNR itself received the October 11, 2016 email correspondence from Ellen Yamamoto, again indicating that service had been successful.

In its Motion to Strike, TOL argues that email correspondence on October 11, 2016 from Frances Soares of the Watanabe Ing law firm "had no contents other than the identifying information of the sender and a disclaimer" and the email "had no attachments." A copy of this email is attached hereto as Exhibit 5, and was sent inadvertently to all parties in this proceeding. The email from Frances Soares did not contain any information or any indication that its purpose was service of the pleadings on the parties. The email from Frances Soares does not change the fact that on October 11, 2016, at 4:56 pm, TIO (via email correspondence from Ellen Yamamoto) provided an email link to the pleadings, fulfilling its obligations to serve all parties in this proceeding with copies of the relevant documents.

Notwithstanding the foregoing, on October 13, 2016, when TIO learned of TOL's Motion to Strike, counsel for TIO contacted counsel for TOL, indicating that service had been completed via email correspondence from Ellen Yamamoto on October 11, 2016, at 4:56 pm, and an offer was made to re-send the same email and link. See Exhibit 7, attached hereto.

In light of the foregoing, the Motion to Strike should be denied. TIO timely served all parties to the proceeding, and upon learning of allegations from only one party that it had not received the email link with the documents, offered to re-send the pleadings within two days of the first email correspondence. The actions of TIO in serving the parties in this proceeding were in accordance with regular business practices, and do not warrant a striking of

the pleadings. Moreover, DLNR itself received the email link and posted all of the pleadings on its website for the parties to access. Consequently, there has been no prejudice whatsoever to TOL. Even if it had not received the October 11, 2016 email correspondence from Ellen Yamamoto, it clearly had access to the DLNR website. TOL's Motion to Strike is clearly intended to unnecessarily delay the proceedings, and is without merit.

II. <u>CONCLUSION</u>

For the foregoing reasons, and all reasons appearing of record, TIO respectfully requests that TOL's Motion to Strike be denied.
