Brannon Kamahana Kealoha Motion Of Clarification Reserving Rights to Participate

Comes now, **Brannon Kamahana Kealoha** with a motion requesting to appear by phone for the scheduling portion of the hearing on Thursday January 26, 2017 **if needed** after taking in the following consideration, herein I also motion for the following as I feel it pertains to this same motion:

- 1) If possible I motion the hearing officer to allow me to call upon Leinaala Sleightholm and Mehana Kihoi as witnesses, they are already petitioners in the case and I hope their testimony can be accommodated regardless if I am unable to come to Hilo 1/26/2017 due to sever economic and hearing scheduling subjugation.
