Memorandum of Support

The purpose of this clarification of the items under the letter "D" became necessary as I have read the objections of University of Hawaii (UH) and those of Thirty Meter Telescope International Observatory (TIO) stating that my Motion to move all documents in evidentiary submittals into evidence (Doc 494) did not separate individual submissions and exhibits.

A quick look into the evidentiary submittals under Harry Fergerstrom letter "D" shows that the way those submittals were placed, did not separate each item by an exhibit number.

For this reason I thought that entering the all the documents into evidence would be correct with the clear exception of the testimony of Williamson

Chang, that would not be placed in evidence, but retained as an
