(Order Granting-In-Part Applicant University of Hawai`i at Hilo's Motion for Leave to Present Rebuttal Testimony (Doc. 461))

On February 21, 2017, a hearing on the Applicant University of Hawai`i at Hilo's ("UHH") Motion for Leave to Present Rebuttal Testimony (Doc. 461) ("Motion") was held at the Grand Naniloa Hotel, 93 Banyan Drive, Hilo, Hawai`i.

By this Motion, UHH seeks leave to have Sara Collins, Ph.D., or in the alternative,
Dennis Gosser, testify as rebuttal witnesses. Dr. Collins is "a Senior Archaeologist with Pacific
Consulting Services, Inc. ("PCSI"), the consultant company responsible for completing the
Archaeological Inventory Survey ("AIS") of the Astronomy Precinct in the Mauna Kea Science
Report ("Astronomy Precinct AIS")." (emphasis removed) Doc. 461 at page 1. UHH
pronounces, "The University initially expected to present Dr. Collins in its case in chief and
timely filed her written direct testimony on October 11, 2016." Doc. 461 at page 2. However,
due to scheduling issues, Dr. Collins was unavailable during the period that UHH presented its
case in chief. Doc. 461 at page 2. UHH informed the Hearing Officer and parties of the
scheduling problems and of its intent to present Dr. Collins as a rebuttal witness. Doc. 461 at
page 2. UHH argues that Dr. Collins' testimony will assist the Hearing Officer in her decisionmaking and that good cause has been shown for leave to present Dr. Collins as a rebuttal witness.

Doc. 461 at page 2. Mr. Gosser would be offered as a rebuttal witness if Dr. Collins was not available when scheduled.

The Flores-Case `Ohana suggests that the Motion presents inconsistent positions taken by the UHH. Doc. 465 at page 2. The Flores-Case `Ohana also raises concerns and reservations about "a PCSI representative being called as a rebuttal witness based upon the credibility of the written direct testimony associated with this firm as previously demonstrated by UHH's witness, Mr. Richard Nees – PCSI Senior Archaeologist." Doc. 465 at page 3. However, the Flores-Case 'Ohana takes the position that it would not oppose the rebuttal witness within a specific limited scope:

- (1) Adherence to the archaeological and cultural review processes as it pertains to PCSI's own document, Archaeological Inventory Survey of the Astronomy Precinct in the Mauna Kea Science Reserve included as Appendix I to Volume 3 of the thirty-Meter Telescope Final Environmental Impact Statement (Exhibit A-5 in this proceeding)
- (2) the credibility of PCSI's own archaeological document noted above
- (3) PCSI's role and contribution to the CDUA HA-3568

 Doc 465 at page 3.

KAHEA objects entirely to UHH calling Dr. Collins and Mr. Gosser as rebuttal witnesses. KAHEA contends that "UHH desires to call Ms. Collins for purposes of rehabilitating the testimony of their own witness (Nees) and mending "pukas" in their case in chief, and that the stated reasons for their request for leave is merely a disguise for their desire to rehabilitate their own witnesses and/or "pukas" in their case in chief." Doc. 466 at page 3.

At the hearing on this Motion on February 21, 2017, the Hearing Officer ruled: "With regard to the University's request for Sara Collins or Dennis Gosser, I'm also granting that request. Again, that testimony, rebuttal in nature, will be limited to the Points 1, 2, and 3 set out in the Flores-Case opposition." Tr. Vol. 38, 2/21/2017, at 28:20-24.

On February 24, 2017, UHH filed a Proposed Minute Order No. ___ Granting-in-Part Applicant University of Hawaii at Hilo's Motion for Leave to Present Rebuttal Testimony, filed February 13, 2017 (Doc. 461) ("Proposed Minute Order"). There were no responses to the Proposed Minute Order.

Based upon the Motion, all related and oral submissions from counsels and/or parties, the Proposed Minute Order and all submissions related thereto, all applicable law, the entire record having been considered by the Hearing Officer,

IT IS HEREBY ORDERED that the Motion is Granted-in-Part.

Motion to Reconsider. A party, who believes it appropriate, may file a motion to reconsider using the procedure set out herein. Any Motion for Reconsideration shall not be used to reargue the motion or set out positions of a purely repetitious nature or to present factual or legal grounds that could or should have been presented at the original hearing. <u>AMFAC, Inc. v. Waikiki Beachcomber Inv. Co.</u>, 74 Haw. 85, 114 (1992).

The deadline for submission of any <u>motion</u> to reconsider this minute order is no later than <u>5 business days</u> after the date this Minute Order is filed in the Documents Library. Any <u>responses to motions to reconsider</u>, shall be submitted no later than <u>10 business days</u> after this order is filed in the Documents Library; essentially 5 business days after the deadline for motions to reconsider.

Any Motion to Reconsider shall be considered a non-hearing motion unless otherwise designated by the Hearing Officer.
