# **MINUTE ORDER NO. 80**

(Order Denying William Freitas Response, to TIO's Opposition to Reconsideration to Minute Order's No. 43, Doc. 604, and Minute Order No. 44 Doc. 614, TIO Opposition and UHH Joinder to TIO Doc 607 and No. 44 Doc. 616 (Doc. 628))

William Freitas filed his William Freitas Response, to TIO's Opposition to Reconsideration to Minute Order's No. 43, Doc. 604, and Minute Order No. 44 Doc. 614, TIO Opposition and UHH Joinder to TIO Doc 607 and No. 44 Doc. 616 (Doc. 628) on May 10, 2017. Other than the Response, there were no other submissions for the Hearing Officer's consideration.

The title of Document No. 628 suggests that it is intended to be a "Response" to TIO and UHH oppositions and joinders to oppositions, to William Freitas' motions for reconsiderations related to Minute Order Nos. 43 (Setting Post-Hearing Deadlines) and 44 (Regarding Documentary Evidence). In Document No. 628's "Conclusion to Response", William Freitas writes, *inter alia*: "I William Freitas Pro-se, under threat, duress, and coercion, humbly ask this

Hearings Officer to 'Grant' Motion to reconsideration filed by William Freitas Doc. 568 in Consideration of rules sited, and reasons stated n this response for a full relevant, Accurate, and 'Timely' government record." [sic] Doc. 628 at page 5.

Document No. 628 is untimely. It was filed on May 10, 2017, several days after the latest deadlines for motions for reconsideration and responses related to Minute Order Nos. 43 and 44.

Minute Order No. 50 (Denying Reconsideration of Minute Order No. 43), was filed on May 23, 2017. (Doc. No. 646) "The deadline to file any motion to reconsider Minute Order No. 43 is April 26, 2017, 5 business days after April 19<sup>th</sup>. The deadline to file responses to any motion to reconsider is May 3, 2017, 5 business days after April 26<sup>th</sup>." (emphasis added) Minute Order No. 50 (Doc. 646) at page 1.

Minute Order No. 51 (Amending Minute Order No. 44 and Granting In Part/Denying In Part Reconsideration of Minute Order No. 44), was filed on May 25, 2017. (Doc. No. 647) "The deadline to file any motion to reconsider Minute Order No. 44 is April 27, 2017, 5 business days after April 20th. The deadline to file responses to any motion to reconsider is May 4, 2017, 5 business days after April 27<sup>th</sup>." (emphasis added) Minute Order No. 51 (Doc. 647) at page 1.

Based upon the Response, all applicable law, the entire record having been considered by the Hearing Officer,
