MAUNA KEA HUI'S MOTION TO SUBMIT NEW EVIDENCE, OR ALTERNATIVELY, TO REQUEST JUDICIAL NOTICE OF THE SAME

MAUNA KEA ANAINA HOU, an unincorporated association, KEALOHA PISCIOTTA; CLARENCE KUKAUAKAHI CHING; DEBORAH J. WARD; PAUL K. NEVES; and KAHEA: THE HAWAIIAN ENVIRONMENTAL ALLIANCE, a domestic non-profit corporation ("Petitioners") respectfully submit this motion to submit new evidence, or alternatively, to request judicial notice of the

same. This motion is filed pursuant to Hawai'i Administrative Rules (HAR) §§13-1-34, -35,¹ and -39. Petitioners' exhibit "A" is a press release from the State of Hawai'i Department of Health (DOH) stating in relevant part that it:

received a Notice of Cessation from the Thirty Meter Telescope (TMT) International Observatory for its National Pollutant Discharge Elimination System (NPDES) permit. The permit authorized discharges of storm water associated with Thirty Meter Telescope construction activities. Since TMT filed a Notice of Cessation, it will not be allowed to conduct further construction work unless a new permit is issued.

Declaration of Counsel; Exh. A.

On May 24, 2021, Petitioners sought to reopen these proceedings on the TMT INTERNATIONAL OBSERVATORY LLC's (TIO) conservation district use permit (permit or CDUP) because it has failed to meet Standard Condition No. 4, which states:²

Any work done or construction to be done on the land shall be initiated within two (2) years of the approval of such use, in accordance with construction plans that have been signed by the Chairperson, and, unless otherwise authorized, shall be completed within twelve (12) years of the approval. The UH Hilo shall notify the Department in writing when construction activity is initiated and when it is completed.

On October 24, 2021, the Board entered Minute Order No. 1, providing a briefing schedule.

On November 3, 2021, Cindy Freitas filed a response in support of Petitioners' motion to reopen.

On November 4, 2021, TIO filed an opposition to Petitioners' motion to reopen and Applicant UNIVERSITY OF HAWAI'I AT HILO's (UH Hilo) and PERPETUATING UNIQUE EDUCATIONAL OPPORUNITIES' (PUEO) filed substantive joinders to TIO's memorandum.

On November 8, 2021, the Flores-Case 'Ohana filed a motion noting it had not been properly served with Minute Order No. 1.

On November 19, 2021, the Board entered Minute Order No. 2, granting leave to the Flores-Case 'Ohana to file a response.

On December 3, 2021, the Flores-Case 'Ohana filed a response in support of Petitioners' motion, noting as further support for Petitioners' motion, that TIO lacked a valid National Pollutant Discharge Elimination System (NPDES) permit from DOH (NPDES Permit No. HI S000431) and therefore could not have initiated construction in compliance with the Board's CDUP Condition No. 4.

On December 10, 2021, TIO filed a request to supplement the record with what purported to be a May 28, 2019 letter administratively extending "the NPDES permit until DOH makes a final determination on TIO's application for renewal of the permit." *Id.* at 2.

On December 13, 2021, Petitioners objected to TIO's request to supplement the record.

On January 24, 2022, the Board entered Minute Order No. 3, granting TIO's request that the "Board take notice of the DOH's May 28, 2019 letter, which is a public record and which gives additional context for the new arguments presented by the Flores Brief." The Board found "allowing a limited supplementation of the record to provide additional useful information to the Board will further the ultimate purpose of this action, to determine whether UHH has complied with Condition No. 4 of the CDUP, will promote fairness, and will not prejudice any of the parties."

Admission of this exhibit as new evidence or judicial notice of the same provides additional useful information for this Board's consideration of UHH's compliance with Condition No. 4. TIO's failure to have obtained a valid NPDES permit means UHH has not and cannot initiate construction of the TMT in compliance with Condition No. 4.

To the extent UHH may contend it initiated construction under a presently invalid NPDES permit, the Board should rescind the chairperson's approval of UHH's previous notice of initiation of construction and reopen proceedings; impose an amended Condition No. 4; and address UHH's compliance with Condition No. 1 (requiring UHH "to comply with all applicable statutes, ordinances, rules, regulations, and conditions of the Federal, State, and County governments, and applicable parts of the HAR §13-5 et seq.") in light of the absence of any NPDES permit for the project.
