Disclosure of BLNR Chair Dawn Chang regarding the Petition of Mauna Kea Hui for a Declaratory Order filed May 24, 2021 (Case No. HA-22-02)

I am the Chair of the Board of Land and Natural Resources (BLNR).

In this capacity, I oversee the Department of Land and Natural Resources' (DLNR) divisions, under authority of the BLNR, including these divisions with management and regulatory jurisdiction over activities on Mauna Kea:

- Office of Conservation and Coastal Lands (OCCL) which has responsibility for regulating public and private uses in the conservation zoned district;
- Division of Forestry and Wildlife (DOFAW) which has jurisdiction over forest reserves, natural area reserves, and trails;
- Division of Conservation and Resource Enforcement (DOCARE) which has responsibility for enforcement laws and regulations under the jurisdiction of DLNR and as otherwise authorized under joint enforcement agreements;
- Land Division (LD) which has jurisdiction over unencumbered State lands and makes dispositions including leases, easements, and revocable permits;
- State Historic Preservation Division (SHPD) which has responsibility for regulating public and private actions with potential impacts to historic and cultural resources

as well as other areas such as water, aquatics, and state parks.

The Mauna Kea Stewardship and Oversight Authority (MKSOA) was established by Act 255 (2022 Hawaii Session Laws) and is administratively attached to DLNR. The MKSOA will have governance and management responsibility from the University of Hawaii and DLNR. The Chair of the BLNR, or designee is a member of the MKSOA. I have designated DLNR First Deputy, Laura Kaakua, to sit on the MKSOA.

I was nominated by Governor Green to serve as the Chair of BLNR and assumed responsibility on January 3, 2023, as the Governor's nominee subject to Senate confirmation. I was formally confirmed by the Senate on April 6, 2023.

Prior to my nomination as the Chair of BLNR, I was the Principal of Ku'iwalu Consulting from 2001 until 2022. As the Principal of Ho'akea LLC dba Ku'iwalu, I was contracted by the University of Hawaii (UH) to prepare a comprehensive management plan (CMP) for the state leased lands managed by UH. Ku'iwalu subcontracted a team of consultants to prepare the CMP, which included The Edith Kanaka'ole Foundation, Sustainable Resources Group International, Inc. (SRGII), McNeil Wilson Communications, PB Americas, Rechtman Consulting, Pacific Consulting Services, Inc. (PCSI). I prepared the CMP from 2007 – 2009.

In 2020, Ku'iwalu was contracted by DLNR to conduct an independent assessment of the University of Hawai'i's implementation of the CMP. Ku'iwalu subcontracted a team of consultants to prepare the independent assessment, which included SMS Research, and People Strategies Hawaii.

I do not believe that my previous work as a consultant in preparing the CMP or independently evaluating UH's compliance with the CMP will affect my ability to be fair and objective in weighing the evidence and arguments fairly.

At no time, was I employed by TMT as a consultant.

I have no personal conflict with respect to any party to the contested case. I am not related to any of the parties or their counsels.

I do not believe my position as Chair of the Board of Land and Natural Resources nor my actions in carrying out my related duties at the Department of Land and Natural Resources create or reflect any bias either in support of TMT or against it, nor would it cause any reasonable person to think that my impartiality in this contested case hearing would be affected.
