NOTICE OF RULEMAKING USING HRS § 183D-3(b), ADAPTIVE MANAGEMENT AUTHORITY

Effective January 23, 2023

Hawaii Administrative Rules (HAR) Amended under Hawaii Revised Statutes Section 183D-3(b) will increase bag limits, and hunting days within the open hunting season.


- 1. HAR Chapter 13-123 ("RULES REGULATING GAME MAMMAL HUNTING"), has Amended EXHIBIT 1, "Game mammals to be taken, means of take, daily bag limits, hunting periods, hunting days, and special conditions for hunting on the island of Kauai.", to Change Open Hunting Days in Unit F from Four Days a Week and State Holidays to Seven Days a Week (Daily) for Designated Open Hunting Periods. See exhibits below.
- 2. HAR Chapter 13-123 ("RULES REGULATING GAME MAMMAL HUNTING"), has Amended EXHIBIT 11, "Game mammals to be taken, means of take, daily bag limits, hunting periods, hunting days, and special conditions for hunting on the island of Hawaii." to Change Open Hunting Days in Unit I at Nānāwake Forest Reserve and Malama Kī Forest Reserve, and Unit D at Keauohana Forest Reserve, in the Puna District on Hawai'i Island, from weekends and State Holidays to Seven Days a Week (Daily) and Increase Bag Limits in both areas from Two to Four Feral Pigs Per Hunter Per Day during Year-round Open Hunting Periods.

Rules made under HRS section 183D-3(b) required the Board of Land and Natural Resources (Board) to find timely adoption necessary to implement effective and adaptive management measures in response to rapidly changing resource conditions. The rule(s) adopted shall be effective no longer than two years, with one-year extensions subject to legislative approval and renewal by the Board.

Adoption, amendment, or repeal of any rule under HRS § 183D-3(b) shall be effective for a period of no longer than two years, subject to legislative approval and renewal by the Board, provided that renewal by the Board shall extend for up to one year at a time.

Each rule adopted, amended, or repealed under this authority shall become effective ten (10) days after formal action by the Board, which was conducted on January 13, 2023, provided that if a later effective date is specified in the rule, the later date shall be the effective date. Final rules are posted at https://dlnr.hawaii.gov/dofaw/rules/ and will remain posted during the duration they are in effect.

Attachment 1: Proposed adaptive management rule changes to be incorporated in Exhibit 1 of Chapter 13-123, HAR.


The adoption of these rules shall take effect ten days after this formal action by the Board of Land and Natural Resources ("Board") (January 23, 2023), and shall be effective for no longer than two years, subject to legislative approval and renewal by the Board; provided that renewal by the Board shall be extended for up to one year at a time. These rules shall be posted on the Division of Forestry and Wildlife's website, where they will remain for the duration of the time the rules are in effect.

These rules are subject to administrative penalties as provided by section 183D-12, HRS.

^{*/4} Hunters must obtain a permit from the Lihue Division of Forestry and Wildlife Office prior to hunting. Game permit-tag fees may be assessed for these hunts. Unit G permits are limited to 30 permits per day on a first come-first served basis. A camping permit from the Division of State Parks is required for over night trips in Unit G.



REGULATING GAME MAMMAL HUNTING, CHAPTER 13-123, HAWAI'I ADMINISTRATIVE RULES, BY AMENDING THE ADMINISTRATIVE RULES REGULATING FERAL PIG HUNTING IN UNIT D AT KEAUOHANA FOREST RESERVE AND UNIT I AT NĀNĀWALE FOREST RESERVE AND MALAMA KĪ FOREST RESERVE, IN THE PUNA DISTRICT ON HAWAI'I ISLAND

Attachment 1: Proposed adaptive management rule changes to be incorporated in Exhibit 11 of Chapter 13-123, HAR. Unit D includes Keauohana Forest Reserve, Hilo Restricted Watershed, and a portion of Kohala Restricted Watershed, but this recommendation only applies to Keauohana Forest Reserve. Unit I includes Kalopa, Honokaia, Nānāwale Forest Reserve, Makaula Ooma tract of Honuaula Forest Reserve, and Malama Kī Forest Reserve, but this recommendation only applies to Nānāwale and Malama Kī Forest Reserves.

The adoption of these rules shall take effect ten days after this formal action by the Board of Land and Natural Resources ("Board") (January 23, 2023), and shall be effective for no longer than two years, subject to legislative approval and renewal by the Board; provided that renewal by the Board shall be extended for up to one year at a time. These rules shall be posted on the Division of Forestry and Wildlife's website, where they will remain for the duration of the time the rules are in effect.

These rules are subject to administrative penalties as provided by section 183D-12, HRS.
