*RKH stated there were no updates or announcements; SHPD working on arranging training, hopefully for February 2018*

**B. Department’s Recommendation to Recognize Laverne Quinones as a Lineal Descendant to the Native Hawaiian Skeletal Remains of Samuel (William) Napua Kaho‘ali‘i, Elizah Kameo Macomber Kaho‘ali‘i, Eliza Kameo, and an Infant Male interred at Burial Site State Inventory of Historic Places (SIHP) #50-10-73-30703, Kamaoa, Puueo Ahupua‘a, Ka‘ū District, Hawai‘i, TMK: [3] 9-3-008, 009**

**Discussion/Determination:** Discussion and determination on the Department’s recommendation to recognize the applicant as lineal descendant of Native Hawaiian skeletal remains at the above location.

*Vice Chair read item onto agenda*

Member Cachola asked if Laverne was present, and asked her to provide testimony

Laverne: This area that we're speaking about, my grandfather owned 140 acres of this area.

HIBC Member Cachola: What is his name?

Laverne: Samuel William Napua Kahooalii. My father is 94 years old, he was 10 when his father died and saw where his father was buried on the family land. Over time, the family lost the ownership of the grandfather's lands. Whole area covered by lava flow, Kahoalii family lands. The only open areas are those not covered by the lava flow.

Norman: Who owns the land?

*Laverne stated the land is owned by a developer, real estate owner in Ka'u; property crosses county road. Grandfather's is still in the same place, surrounded by rock wall under mango tree. Grandmother and infant, both died in childbirth, buried outside the area. Has visited the area to keep it clean and maintain it. Has been told by landowner previously that they are not welcomed there.*

Member Cachola: Are the gravesites marked?

Laverne: Not previously, but they are now.

*Member Cachola commended her for keeping area clean.*

*Laverne stated her father wants to eventually visit the area.*

HIBC Member Cachola: Is the landowner aware of the burial locations?

Laverne: No.

Member Cachola said the owner of the TMK should be on public record. To continue to malama your kupuna, the entity who owns that property should know that. Have you filled out the papers?

Laverne: Yes. *Met with Kauanoë on site. Laverne's father wanted to place a headstone on there but Kauanoë suggested she keep the burial preserved as traditionally as possible.*

HIBC Member Cachola asked about the location and how the site is accessed.

*Laverne stated the site is located opposite of rock wall. Hikes through the lava to get there.*

Member Cachola: Landowner not pleased about it.

*Laverne stated that across road, in the house with a blue roof, the neighbor recognizes Laverne's car now and doesn't come out and chase her away.*

Member Cachola stated that Laverne's information about the burial location and who is buried there was filed, and that she knew where this site is.

*Laverne stated she knows it, and her father knows where it is. So does her cousin, who passed away last year. Cousins and family would visit the gravesite and put flowers every weekend.*

Member Cachola: Important to know.

Member Cachola asked RKH what the department's recommendation was based on, and if the burial registration was completed.

*RKH commented that the recommendation was written by another burial sites specialist, who also completed the burial registration. The burial site was given an SIHP [State Inventory of Historic Places] number, indicating it had been registered with the SHPD.*

HIBC Member Cachola: moves to recommend acceptance of lineal descendant to Laverne Quinones

*Mikiala: born in Kahaluu, parents are Mitchell and Violet Kahanu, raised by Kaiuhina Kahulamu (grandmother) of Kahaluu, tutu was 17<sup>th</sup> child of 18, who was born in 1893, would be 125 years today, her father was John Robert Kahulamu, whose brother is , her daughter is E. Hamm. Thomas Kahulamu is tutuwahine's brother, they are kuku to Ralph Alapai, and Velma Kauahi, line goes all the way back to Kealiihulamu, Kaloakukahi, down to Kuaalu.*

Mikiāla: "Why am I denied?"  
Member Cachola: Mahalo for the genealogy.

(Amy arrived at 10:06 AM)

*RKH read from the BTP regarding the two properties with skeletal remains*

*Mitchell comments*

*RKH comments*

*Member Cachola comments*

*Mitchell comments*

HIBC Member Cachola: *believes that Mitchell disagrees with the recommendation, the individual in the AIS*

Mitchell: "...No one is claiming it, no name, no one is going to take care of it."

Vice Chair Kaimuloa: "...KS re-discussed the bones found, came to the conclusion that they would make a vault, and put all unidentified bones in the vault."

*Member Cachola asked if there were any KS representatives*

*Malia stated she does not have the authority to speak on behalf of KS*

Member Cachola: "Is there an official representative of the KS to verify what was said?"

*Malia: (came forward to speak) Malia Kipapa, KS, Ed. Program administrator, assists Mahealani who is the cultural resource specialist. These 5 descendants being denied lineal descendancy were assisted by Malia, will take responsibility for that personally. Utilizing the process the State has in place to recognize descendants.*

*Uncle is the kahu of the area for Kahaluu, he is the person we ask. Bring the kupuna to this point to justify their lineal descendancy. Technicality to the state. Kalani Hamm is here too. KS still confides in the family as a landowner, and to be in communication with the families being a good landowner, asking the families their opinion. Can't tie the iwi to uncle specifically. Uncle is a kahu to the gravesites of the area. Others are representative, lineally, to KS.*

Vice Chair Kaimuloa: "...The decision made by our (SHPD) administrators, the decision can be appealed, and go through the process again."

Malia: "What needs to be done in the process for them to be accepted?"

Member Cachola: *Commends KS for what they are doing. There was a time they didn't do what they do now. "...Not denying lineal descendancy of the area, only to the two unidentified iwi found during the AIS. We do not know their names. Unlike Laverne, who knows the identity of the bones. In this case, the burial treatment plan, no mark, don't know. You can tell us who the names are of those buried in the family plot. Case is whether we will accept the denial for lineal descendancy."*

Vice Chair Kaimuloa: "He was told why he was denied, and he knows now why he was denied. Can vote, or table it. As of now he's a cultural descendant. Is that sufficient?"

Vote is to be recognized as a cultural descendant.

Vice Chair Kaimuloa: "He can appeal or not appeal."

Chair Kekipi: "I voted to recognize him as a lineal descendant. Department says I voted erroneously. They cannot identify if it's not."

Vice Chair Kaimuloa: "When Herbert handled the HIBC, these recognitions were not on the agenda. The family came to the HIBC meeting and the paperwork was filed and approved. It is now on the agenda. It is more pono than the last time. The past had lots of problems, and this is one of them. We vote today, on what is on the agenda. If there will be an appeal, please do so."

Terri: I want to clear this. The department denied him. We are voting today to recognize him as a cultural descendant. Appealing tables the issue.

HIBC Member Cachola: He cannot appeal if we do not decide.

Member Napeahi: “Regarding this issue, we have 4 things have been denied. Uncle has a point about the revised statutes and laws, only changed by legislation or lawsuits. Regardless of whether I know the laws in place here, we as a council are here to support the Hawaiian people. If you are recommending we are changing here, how do we do that?” *Need the specific law about the process. Contesting lineal descendancy.* “We gonna deny you and this

is what we need to do. Where can we challenge the state rules and not ours, a lawsuit, or legislation?"

Member Cachola: *Thinks that law needs to be changed.*

Vice Chair Kaimuloa: *off topic*

Chair and Member Napeahi: "It's on topic."

Chair Kekipi: Familiar with what Jimmy is saying, because Jimmy was previously recognized as lineal descendants by the Council

Member Cachola: "It bothers me," *accepts that he is out of motion. Suggested SHPD bring legal counsel here.*

Member Napeahi: Have the AG present.

E. Hamm (summary from testimony): *All the 'buts', the family has lived on the land there up until the 1970's, received notification through telephone and email from Malia; yes said to the kupuna of 1880's and beyond, what about us Hawaiians (as said by Jimmy). How to take*

*back to word once it's been said. Sorry kupuna the state made a mistake; we don't know what went wrong, we should've done that, or this. Today I stand in front of you, cultural, to remove what was already said; cannot carry that burden. We cry. We look to you as someone that can help us. The power of this body since it started; how many kupuna have come and sit here before? Henry Auwae. Plenty others sat in the same seat. What was they say? What was their thinking? What was the intent of a body like this? The law should be changed, a long time ago. Things are moving so fast, in Hawaii and in Kona, for the good and the bad, we have to prove who we are, not only to you but to others.*

Member Cachola: *Thanked applicant for their testimony. Would like to call for a 5 minutes executive session.*

Summary:

*Hokulia has a long historic preservation history; always some doubt whether all HP sites have been adequately documented in the project area*

*3 central ahupuaa (listed above), located on the pahoehoe flow, extensively modified across the entire thing,*

*Mikey: 300 acres approximately, Sol led the crew that resurveyed the area, thousands of agriculture related sites and other types of sites, going through the preservation of those site  
Going through the process, some parcels have been sold off,*

*Some areas are not covered by the property ownerships, those are outside 1250  
For those inside 1250: Treat these burials with a stone wall buffer, turn over to parks and  
cultural sites management for maintenance*

Chair Kekipi: *working with the descendants?*

Mikey: “yes, working with the descendants to preserve in place, perfect square permanent  
rock wall that closely resembles traditional burial site buffers...”

Jimmy: *Supports plan. These sites were found in the last, most recent survey, the BTP will  
support the protection of these areas. These 4 were found during this survey.*

Member Cachola: *Commends the archaeologist for consulting with the descendants. Several  
comments: certain burial sites along the golf course could be better protect, such that the tees  
are redirected so the golf balls and golfers are going in one direction and least likely to go  
into the burial, may need to realign tees for those purposes. 2) These burial plans that have  
been developed become a covenant between you and the land, a promise between you and the  
kupuna, and should be a covenant between everyone who occupies that land, and need to  
know the promises that have been made. Part of the conveyance papers need to include this  
treatment. Bought into an area that is very significant.*

Mikey: “That is included in the plan (read directly from plan).” *Will be on property deed as a  
restricted area. Access for CD and LDs is established in the BTP.*

Keiki: *CCNRs*

Mikey: *.....Access for CDs is in the BTP, coordination with cultural resources group (on  
the side)*

Chair Kekipi: “Who is the landowner rep?”

Mikey: “1250 Oceanside, LLC.”

Member Cachola: “Full disclosure?”

Mikey: *Packet given to each prospective owner, including what responsibilities exist.  
(PCSA??) Buying the lot as is, what is in place.*

Vice Chair Kaimulua: *Met with Mikey and Jimmy at a burial site there. Hokulia, now, before  
the owner can build on the property, there is a survey done to record everything before the  
owner can build. “Good plan, doing a good job. Keep up the good work. Some developers  
and some archaeologists come (here) and play is as fools. Went through the ringer already  
and now know what the right thing to do.”*

Keiki: *Mahalo for what is being done. Esp. for any burial found will be considered previously  
known, not inadvertent. BTP has already identified burial buffers, but when the building  
plans are given, what is the building footprint, i.e. where is the sewage, where is the effluent  
running, where is the driveway? Those need consideration and must come with the plan.*

HIBC Member Cachola: *move that the submitted plan be submitted.*

Mikey: *recommendation for preservation in place is what is being requested.*

Norman: *doesn't believe in moving any bones.*

Mikey: *Could include the motion for preservation in place.*

Motion: *to recommend the SHPD accept the submitted BTP*
