- 11:00 SHPD interested in helping applicant through the process. Applicant stated that she would be off island on the day of meeting. Unavailable.
- 12:15 Council Chair Fisher open item up for public testimony.
- 12:20 Cheryl Hota support Ms. Kamekona descendancy recognition; testify on her behalf. Ms. Hota explained that Ms. Kamekona on the mainland attending mo'opuna graduation. Ms. Hota provide a copy of applicants descendancy application to council.
- 13:40 Clare Apana in support of Ms. Kamekona descendancy recognition. Ms. Apana remembers many times needed to go before council. Hard on applicant. Issue with documents. Ancestor went all over moku. Perhaps why previous council used to approve descendancy. Ahupua'a restricting.
- 15:22 Look at what landowner/developer. Taken control over iwi. Should be SHPD. What is limit. Can limit descendant from being involved with mālama iwi kūpuna???? Guidelines for landowner. Iwi not protected as well as should.
- 17:42 Guidelines outlined in burial treatment plant asked Chair Fisher. Ms. Apana stated recognized descendants should be consulted with when drafting plan; not happening, mostly not, rarely.
- 18:18 burial treatment plan act as guidelines. Should be able to modify. Created by descendants. Kawaiha'o an example.
- 19:41 Carol has not been consulted with by landowner re: burial treatment plan. SHPD has
  done consultation. GWR has asked that SHPD conduct the consultation per the rules because
  of a lack of relationship between the interveners and the landowner team.
- 21:00 Option is for council to make a motion that GWR consult.
- 23:00 Need to follow process stated Councilmember Hoopii. Vetting process with SHPD before recommendation made; go before council.
- 25:00 Ashford DeLima, already recognized cultural descendant to this iwi kupuna. Has he been consulted with?
- 25:30 Councilmember Hoopii reminded council of purview. Deciding on recognition, based on SHPD recommendation. Should not get involved with forcing landowners to consult, especially if not present at meeting. If present at meeting, can help facility (both parties there).
- 26:45 SHPD clarify, contracted arch firm CSH submitted draft BSCADRP to SHPD for review. Asked SHPD to consult with appropriate parties.
- 28:30 Foster Ampong address council. Disturbing. Address agenda item. Follow process. Application not vetted by SHPD, any further discussion mute. ATP not on agenda. Related somewhat, separate issue. Not agendize. Should not be discussed.
- 30:00 Ancestor not linked to ahupua'a. Issue of moku vs. ahupua'a resolved.
- 31:00 Ms. Kamekona need to link genealogy to Kauholanuimahu. Twelve generations separating ancestor to Ms. Kamekona. Provide info to State; state provide recommendation to council can move forward and go before council per Chair Fisher.
- 31:42 council independent of SHPD. Can make own decision, regardless of SHPD recommendation. Not often, cause for concern.
- 32:00 Ms. Kamekona stated she did provide requested info; acknowledge SHPD still reviewing application and supporting docs.
- 33:30 Chair Fisher asked that applicant need to link herself to Kauholanuimahu (12 generations) who is known as to have lived in the area.
- 34:00 Ms. Kamekona asks that in light of the pending deferral of her application, will that restrict her from being consulted with for this iwi kupuna in question. SHPD consult with all interested parties, regardless of recognition.
- 39:00 Many documentation can be submitted to provide genealogical connection.
- 40:00 Council need applicant to connect herself to ancestor in ahupua'a with documentation. SHPD vetted, provide council with recommendation can move forward; go before council. SHPD ask for more time to review application.

- 1:18:00 Chair Fisher introduce agenda item.
- 1:18:30 Chair Fisher provide context re: work/discovery. Po'o iwi, femur.
- 1:19:00 Still in process of hiring arch firm. SHPD arch Iolani Kauhane conducted site visit. In fill. Not in primary context. Iolani not on call. Did provide write-up in hardcopy in folder, available digital as well.
- 1:19:30 Discussion about disposition. In fill; septic system. Probably not a good idea. Io recommendation to have monitoring done for remainder of project. Haven't discussed determination yet. Couple firms contacted. SHPD continue to work with landowner, family.
- 1:20:12 concern of family. Without septic. Need to do right thing. Backfill. Sandy matrix. Did not originate from area. Unsure where.
- 1:21:00 council recommendation to relocate on site, unless evidence can be found of where it originated from. Sand could be from anywhere. Short term preservation recommendations. As it is right now, until disinterred, measures taken to ensure iwi kupuna located together.
- 1:22:05 not sure what Io report says, initial suspicion is MNI of 2. Po'o iwi child; femur child. Possibly two people.
- 1:22:45 haven't talked to homeowner yet. But hoping, they are willing to host iwi kupuna. Eventually going to need to produce an arch data recovery plan or preservation plan. Once submitted to SHPD, will consult, and hope to expedite process; do right by the iwi kupuna.
- 1:23:12 Chair Fisher willing to kokua. Friend is doing excavation. Where sand came from? Unknown. Could be from Nā Wai 'Ehā all the way to Baldwin beach. Dunes. Hard to say. Found shells, 'opihi. Closer to ocean. Not Kula. Chances are coming from the coast. A lot of coast. Family willing to care for iwi kupuna.
- 1L:24:12 Next step, landowner request LOD from SHPD. Plan submitted to SHPD for review, acceptance. Then move forward. Few more steps; follow process. Need to consult.
- 1:25:00 Relocate outside of project area. Respectful. How big lot. Where to relocate.
- 1:25:30 Close agenda item.




Nā Wahi Pana o Kapukaulua


## Project Scope Summary Dune Delineation, access paths, irrigation, and native plants





Designate access pathways and restoration areas with posts and rope, install temporary irrigation, and plant native plants.


## Project Scope Summary Debris Removal

## **Project Scope Summary Sand Relocation**




Sand from dune blowout will be relocated from the Spreckelsville end of the project area to Baldwin Beach Park to create dunes (~1,697 CY)

## Restoration Zone 4




New dune fills using relocated sand from Sprecklesville end of the project



Minor grading of shoreline scarp to a 3 to 1 slope to remove fine grained sediments from the shoreline and allow beach sand to accumulate.


