  - Project area is roughly 363 acres
  - 18 archaeological surveys have been done in the vicinity
  - Most of the cultural features are historic
    - Nothing in the immediate vicinity
    - No iwi have been identified
  - Did a pedestrian survey
  - Ranching features such as a water tank and concrete trough
  - Area has been heavily impacted by ranching activities
  - No cultural deposits were encountered during trenching
  - Backhoe testing was done to get “below” the ranch layer
  - The location of the project is not located on the pu‘u
- Julia Mancinelli
  - Project is located on Parker Ranch lands
  - Working with Waimea Hawaiian Homesteaders’ Association
- Member Ka‘imulua
  - Project plans and what the design will look like
- Member Haumea
  - Excavation work
    - Depth of backhoe and adequacy of testing
    - What was there before the ranch came
    - Iwi would be low, prior to ranching
- Member Mahoney
  - Iwi is most important
    - Intent of the 54 trenches should be to look for iwi
    - Trenching seems like an intrusive type of testing

  - Confirmation that no iwi were discovered
  - Requests for copy of PowerPoint

  - Burial site is grandmother’s
  - In 2016, submitted three sets of documents to protect iwi at three different locations but at one of the sites, a burial registration was done but the burial was disturbed because no permit was needed by the County

- Was told by two SHPD representatives to prepare a BTP
- Document that was prepared contains information necessary for the HIBC to approve request
- Selling property and escrow is closing within the month
- Requesting an easement be placed in the BTP to access the graves
- Hired a surveyor to create boundaries of the gravesite
- Asked the State about an in-situ burial agreement
- Acquired property quiet title court case
- Next step in the process and council's involvement
- Chair Kahakalau
  - Location of the burial
  - Is it possible to remove the burial from the sale of the property to keep for family and maximize protection of the iwi (Ugalde, there are over 30 descendants and can't get them all to agree)
  - Concur that the rest of the family has an opportunity to comment
  - Long-term preservation measures and signage
  - Nice to see kanaka preparing the BTPs
- Member Ka'imuloa
  - Why is the family selling the land – to eliminate the problem, don't sell the land
  - All these other issues come in when the new owner wants to develop
- Member Mahoney
  - Consensus of the rest of the family regarding disposition (Ugalde, some want and some don't)
  - Conclusion of the rest of family
    - Problem when half the family wants to preserve-in-place and the other half wants to relocate
- Member Haumea
  - Supports consulting other family members

  - Family needs to be consulted

**Notification/Discussion:** Notification and discussion on the above correspondence.

**Summary:**

- Keone Kalawe
  - Multiple cemeteries in the Kumukahi and Kapoho area
  - Would like to see a preservation plan and archaeological survey of the area
  - When the desecration occurred back in 2000 the AG did not want to take on case
  - HPD and DOCARE did not read Miranda rights to the three individuals who desecrated the burial crypts and so they got away without punishment
  - How can the HIBC help to bring the iwi back
  - Would like copies of the documents
  - Opening of Highway 132
    - Did not consult with descendants
    - ATV tours
    - Running over petroglyphs
    - Road should not have been opened in the first place
  - There was one big cemetery and the road took out the middle
  - Kumukahi is sacred and not a place to make money or development
  - Requests for executive session
- Keikialoha Kekipi
  - Went to NHLC in the past and met with Moses Haia
  - Road being used only for recreation
  - Area will be heavily impacted and coast will change
- Member Haumea
  - The HIBC can do a strong recommendation to do something to move forward
- Vice-Chair Blakemore
  - Went on site visit with Keiki and Kea
  - Had a community meeting and found that six more burials have been disturbed
  - Solution to start the process and move forward and think outside the box
  - Motions to enter into executive session to discuss the burials at Kumukahi
  - Follow-up when the site numbers were given
  - Motions that the discovery of all information be cc’ed to Kamakana Ferreira, Keone Kalawe, Keikialoha Kekipi, and Lono Lyman
- Member Ka‘imuloa
  - Try a different route – seek legal assistance
  - Agrees with Member Mahoney to start the process from the beginning
- Kamakana Ferreira
  - Compliance Specialist for OHA



- 6E enforcement
- Had a conversation with Sean Nāleimaile at SHPD and was told that there would be a site visit with SHPD and DOCARE to investigate the recent incidents
- Informed that the State might not have the iwi
- Who currently owns the property (Kea, the two original owners are still the current owners, according to the County's TMK website)
- Would like to request a copy of the DOCARE report and confirmation that SHPD has custody of the remains
- HIBC should pass a motion to have the landowners take responsibility of the remains
- Were the sites registered burials at the time of discovery (Kekipi, they have site numbers)
  - Jurisdiction to HIBC
  - If there were site numbers, then they are previously identified (Kea, does not know when the site numbers were given)
  - Confirmation whether the sites were or were not previously identified because they have a site number (Kea, they might have a site number but that doesn't indicate that they were previously identified because it depends on when they site numbers were given – before or after discovery)
  - SHPD to figure out when the site numbers were given to determine jurisdiction
- Member Mahoney
  - There is only a preservation plan and not a burial treatment plan
  - Start the processing from the beginning
  - Why would not UH agree to the original agreement
- Lono Lyman
  - Represents Lyman family and is aligned with what Kalawe is asking for
  - The vision for the area is preservation
  - Land swap between Kapoho company to take possession of land
    - Kapoho Land and Development Co. Ltd.
    - Property owner of adjacent 1000 acres
    - TMK that everyone is using to trespass
  - Would like to see the issue move forward
  - Has an agreement with the County for access
- Member Higa
  - Would like to see maps
- Kea
  - The DOCARE report from 2000 stated that Marc Smith took possession of the remains and therefore, was able to locate the remains in the SHPD collection
  - Can do a transfer of custody when the descendants are ready
  - Nāleimaile has been looking for the right person to contact at UH to work with
  - Will look for more background information
    - Are the remains to be considered previously identified or inadvertent discoveries
  - Original document was written as a Memorandum of Agreement and UH didn't sign the document
  - Spoke with Kamana'o Mills who said he didn't really remember the case
  - Include History & Culture staff when emailing SHPD
