# [9:46] Dane re-opens the main session

[9:46] Sharon Paris – we have completed our exploratory digging and are rerouting road B and attempting to find corridor that bypasses identified remains and provide additional buffers. Completed the digging and found corridor to reroute. Final approvals from DSA for the new road and affiliated construction utilities are being sought but not yet approved. Once DSA approval comes through, then prepared to prepare the final layout of the burial preserve area and that would be in anticipation of preparing the final burial site component of preservation plan for remaining features not covered by previous plans. Planning to do burial site component of data recovery plan to address reinternment of iwi relocated or scatters recovered. Will be consulting on these reinternments. Construction ongoing on eastern side of preserve area.

[9:49] Dane requests sewage lines be present in the next map and meeting and also fragments of iwi kupuna in 144

[9:50] Sharon – since the utility hasn't recieved final approval yet she does not want to disclose location

# [9:51] Kahele opens public testimony

[9:52] Noelani Paresa – Provides clarification on lot 144. She and Noelani went with Kealana and Nico to see the area. She stated concern regarding the scattered iwi in Zoom and site visit. They had already been moved from the area at that time. She felt they should not have been moved. She never received information on the second BSCPP. Concerned at lack of buffer zone.

[9:57] Noelani Ahia – echoes Noelani Paresa's testimony on Lot 144. Feels disarticulated iwi and iwi that are not in situ should be reinterred back in place they were found if safe. She states that descendants never saw the second burial sites component of preservation plan that HBT mentions in a letter she reads. She feels SHPD ignores the preferences of the descendants when approving plans. The buffer zone is not sufficient

[10:03] Kahala Johnson – concerns regarding SHPD not consulting descendants. Survivors and transformative justice – carelessless on the part of SHPD promotes this and does not center the ea of survivors but power of SHPD and developers. Community trust is broken. Survivors are harmed by lack of communication.

[10:07] Kaniloa Kamaunu – from Waihe'e. Malama ka Kanilua and Aha Moku o Wailuku. This area has been a fiasco. So much agony. What the burial council should and must do – there must be violations and fines.

- [10:11] Sharon speaks to what Ms. Ahia said about what happened with TS187 lot 144 sent letter Aug. 17, 2021 to MLIBC. 5th motion recommended return of all stockpiled sand assoc. With iwi inadvertnently discovered June 30, 2021. Iwi were recovered in accordance HAR 13-300-32-d for comingled remains and material other than recovery of remains was never removed. Placed back where it was recovered. Consulted with council and descendants.
- [10:14] Kahele iwi found in 144 were returned to 144?
- [10:14] Sharon no they will be reinterred but additional consultation must occur
- [10:14] Kahele that is the meeting where we challenged the term scatter. They are still iwi kupuna. Descendants requested iwi be returned to lot 144.
- [10:17] Sharon Nov. 19 2021 is when SHPD approved.
- [10:17] Kahele so you know descendants want to preserve in place but you are building a house there?
- [10:18] Sharon technically there are no provisions in statute for disarticultaed remains because they are considered to not have an in situ component particularly as they are in previously disturbed fill in this case. They take comments and make concessions but can't do 100% of what people want. On behalf of her client she can't give a satisfactory answer.
- [10:19] Kahele SHPD and HBT should have consulted before approving.
- [10:19] Sharon our consultation is cumulative and ongoing. Entire preservation plan is not finalized yet, if previously approved must be ammended anyway and consistently expanding buffer areas and preservation areas. They do take things in consideration and meaningfully integrating comments.
- [10:20] Dane how to justify need to relocate throughout Maui Lani. Even if you have a preservation area, the preference is to preserve in place. New BSCPP will this be common practice to take comments from first and apply to the second going forward?
- [10:22] Sharon she feels they meaningfully consulted
- [10:22] Dane he says MLIBC consulted after the fact. He wants to know why SHPD relocated from lot 144. Iwi is iwi even if disarticulated. Was the Wailuku rep contacted?
- [10:23] Sharon recovery measures for scattered iwi are different than relocate or preserve in place. Asks Nico
- [10:24] Nico can not comment if Kealana contacted Wailuku rep. Final disposition will be BSC-AVR. Speak to final preservation boundaries and process individuals reinterred.

[10:25] Kahele – to get houses built in 144 and 145 you proceed with a process you know is rejected by descendants and rejected by the burial council yet moving forward.

[10:26] Marcus – haven't started the home on lot 144 or lot 145.

[10:26] Johanna and recognized descendants notified July 6th and site visit July 7th. Notifications did occur.

[10:28] Noelani Ahia – if this was truly cumulative, they would include all the comments over 5 years. She wants commitment house will not be built on 144 until there is a preservation plan. Other houses going up elsewhere with buffer zones they were never consulted on.

[10:31] Noelani Paresa – she was invited to a scheduled zoom meeting and Aunty Johanna responded. Nico described the scattered remains. He was in front of a house halfway built describing scattered remains. She expressed concern and requested in person site visit. It was peak covid time. She asked they not desecrate further but had already been removed. Asked for buffer zones.

[10:33] Kahala Johnson – gaslighting. Brings up the language of survivors. Rather than developers actually listening and hearing the harms being done, you are backing up and trying to prevent liability. We need you to listen. This does not set a good precedent for community trust.

[10:37] Kahele closes public testimony

[10:38] Kyle – he is confused. Developer say they are not building on the lot. Descendants said they were developing on the lot and Nico has film of this. SHPD personnel involved are not at the meeting.

[10:40] Dane – one house lot is being built and another is not being built on

[10:41] Kahele – Kahele wants confirmation lot 144 that lot won't be built until meaningful consultation on behalf of developer and SHPD occurs. If they are found there, leave them there whether original or secondary context.

# [10:54] Scott makes a motion:

MLIBC recommends meaningful consultation be conducted with both members of the MLIBC and lineal and cultural descendants of the moku and ahupua'a regarding Lot 144 by both HBT of Maui Lani, LLC and SHPD; and the MLIBC recommends suspending construction on 144 until such time that consultation has been completed.

[10:55] Seconded by Everett, all in favor, none opposed except Iris Pe'elua who recuses, motion carries [10:55]

- [11:05] Marcus: All eastern lots, 13-20, 139 a, 201-207a in various stages from homes complete to complete shortly. 145 and 144 have not started vertical home construction yet. Foundation not layed yet. Some retaining wall work and electric lines going on. Ultilites and sewage but no water
- [11:05] Kahele opens public testimony
- [11:06] Noelani Ahia BSCPP was accepted without consultation. She thinks SHPD should retract and MLIBC should request SHPD to retract and SHPD should request from public works a stop work order. Must be sent to descendants. Pending settlement agreement but she does not consent to this project. These are just parameters which would allow her to drop the lawsuit.

- [11:20] Everett discussion of setbacks. Has burial council taken position on setbacks and buffer zones? Community could benefit from some guidance from the council
- [11:21] Dane— the burial site working group will provide comment to the legislature. Maui should also let a stance be at the discretion of the regional reps and also descendants

- [11:24] Sharon wanted clarification on language "until such time...and resolution has occurred..." What does resolution mean? Divergent interests.
- [11:26] Kyle some cultual and lineal descendants said they were not contacted or have input. Disconnect between SHPD trying to connect descendants with developers. Discussion between archaeologists and cultural descendants that buffer zones would be provided and not remove iwi but yet it was removed and there are no buffers.
- [11:29] Dane—resolution is actual meaningful consultation has taken place and not recycled from a previous one. New consultation for the BSCPP
- [11:29] Kahele can use as example the consultation for the first BSCPP. Path for second plan was very different
- [11:30] Scott some good faith effort at arriving at a resolution can be reagendized with MLIBC if not possible
- [11:32] Kahele –wants to recommend a stop work order for areas identified in plan
- [11:32] Dane requests to county to pull the permit
- [11:33] Sharon A potential stop work order was not agendized today

- [11:44] Noelani Ahia plans being redone. Chair Maxwell and her had a site visit. Two burials want to put a wal in between and they are working on a redesign. Happy with design for site 3.
- [11:45] Kaniloa Kamaunu They were talking to someone in charge of the area for the county but no updates. Aha Moku not being consulted.
- [11:49] Clare Apana she keeps getting left out of consultation
- B. Inadvertent Discovery of Human Skeletal Remains During Screening at the Waiko Light Industrial Project, reported to the Maui Office of the State Historic Preservation Division on October 29, 2021, November 3, 2021, November 4, 2021, January 10, 2022, January 11, 2022, January 12, 2022, January 14, 2022, January 24, 2022, January 25, 2022, January 31, 2022, February 2, 2022, February 3, 2022, and February 4, 2022, Ahupua'a of Wailuku, District of Wailuku, Island of Maui, TMK: (2) 3-4-013:075.
- [11:51] Leilani Pulmano Updates since they last met in September. Screening resulting in 220 human skeletal remains and minimum number of individuals to 4. Over 95% of the bones found

are faunal bones. Screening pushpile A is 65% complete. Working through the redesign. Meet weekly with cultural descendants and provide weekly updates.

[11:55] Dane - please put the chair on notification of inadvertent discoveries and gatherings of cultural descendants

[11:57] Mike Dega - Fractions being picked up are smaller than a marble

[11:57] Leilani - the screening method is cambert application system

[12:00] Scott - what is the mesh size on screen

[12:00] Leilani - 1/4 inch

[12:01] Scott - says this is a standard size screen

[12:01] Dane - newly elected chair and vice chair should take a visit to the site

[12:02] Mike - sediments go to ¼ inch but also can be caught in other piles. They look at everything twice

[12:02] Mike Dega – the sheer volume of faunal remains is impressive at this site so it is very laborious

[12:02] Kahele opens public testimony

[12:03] Pam Crabtree  $-\frac{1}{4}$  inch is very standard for mesh size and it seems very reaosnable

[12:03] Jocylyn Costa–Where are origins of pushpile and also estimation of how many total people given fragments – omit minimum number of individuals from this report unless it is gauranteed this fragment belongs to this person. Will there be more finds? It is not truly inadvertent if you find more people

[12:05] Kahele close public testimony

[12:05] Leilani – origins of the pushpile – one is a pre-existing stockpile, not sure where that came from, the second a cow feed lot where cows were buried, and third was from their grading from the work they did.

[12:06] Mike Dega - answers qustions regarding minumum number of indviduals and by definition individuals not found during an AIS are inadvertent

[12:07] Lailani Pulmano - Completely finished pushpile B, the smaller one, and for pushpile A about 65% completed. Took maybe 6-8 weeks to get to 65%

C. Inadvertent Discovery of Human Skeletal Remains at County of Maui Puamana Park, 0 Pualei Drive, reported to the Maui Office of the State Historic Preservation Division on December 7, 2021, December 27, 2021, and January 25, 2022, Ahupua'a of Polanui, District of Lāhainā, Island of Maui, TMK: (2)-4-6-033:001.

[12:09] Ikaika – iwi left in place and covered after exposure from natural erosion.

[12:10] Kahele opens public testimony

[12:10] Ke'eamoku – they requested BTP in december last year in front of MLIBC. Originally one box with 5-7 iwi kupuna. Now a total of 5 boxes in his curation. So many iwi washing up. If they aren't there, tourists will take iwi to the hotel. He feels the kupuna have been with him for too long. Need SIHP number before reinternment. He wants SHPD to let him reinter.

[12:17] Scott - what still needs to be done

[12:17] Ke'eaumoku Kapu - need to finalize another document to get iwi from the state. Has waited for so long to do this and wants to put iwi back. Once the pull box comes they are prepared. They have permission from the landowner. What else does SHPD require before he can take kupuna home? He can't wait anymore. His curation is overwhelmed.

[12:19] Fay McFarlane – she is meeting with parks tomorrow to discuss final details. Pull box estimate is coming. But may need to go in repetitively so because of that she is custom pricing a cylindrical lock for SHPD, the County. Because they fulfilled kuleana for SHPD she had hoped SHPD would be helpful. County is providing land and resources for the crypt but they are doing the edits of the BSCARDP to reflect every date iwi are added to curation. Previously had a promise from SHPD that they would generate SIHP numbers but now SHPD is saying no, the descendants are responsible. The hui of descendents authored the BSCPP.

[12:25] Ikaika – county property exposed from erosion. When they got to the site, they covered with sand and left in place. Significant amount of iwi exposed on the coast line.

[12:25] Kahele opens public testimony

- [12:25] Jocycyln Costa asked to have a gathering at the site an in attendance was county archaeologist, county parks, SHPD, private landowner in the area Malama Kaulahau, an Aha Moku reps. In consultation. Parks department walked coastline and iwi were there to greet them. Even more urgency.
- [12:27] Kahele closes public testimony
- [12:28] Kyle– amazing to him what happens when people decide to put heads together. This is meaningful resolution
- E. Inadvertent Discovery of Human Skeletal Remains at Kapuna Seaside Subdivision-Waihe'e, near Lot 7, reported to the Maui Office of the State Historic Preservation Division on January 31, 2022, Ahupua'a of Waihe'e, District of Pū'ali Komohana, Island of Maui, TMK(s): (2) 3-2-002: 001 and 043.
- [12:38] Ikaika not sure where the iwi is at this point
- [12:39] Lisa Hazuka is the archaeologist for this project. The iwi is stored in a locked box in a baseyard at this time. Only 5-6 fragments at this point. Putting in an 8 inch waterline in existing roadway. Recovered fragments in installation of waterline. This individual appears of have been disturbed before, but don't know when how or who. Landowner wishes to honor location where remains were found. Bone shafts of the legs and small fragments from a clavicle and two ribs. The wall is 500 feet away from where they found these remains. Some iwi in the trench is very fragile and to do anything further would be destructive.
