Defer to the next meeting to make changes [9:26] Chair Hanapi Hirata: For the community, if you wish not to be recorded, email Kealana Phillips. There are rules on public meetings.

IV. BUSINESS

A. Descendancy Claim Application of the Nākī 'Ohana (Names Attached) to Unidentified Human Skeletal Remains at 8303 Kamehameha V Highway, Ahupua'a of Mapulehu, Kona District, Island of Moloka'i, TMK: (2) 5-7-008: 076.

[9:27] Chair Hanapi Hirata: Applications for descendancy were not sent to review. They are all for one land parcel. The Chair says she has not been able to answer questions of community members. She asked community members via kāhea to see who wants to be identified. She recommended they discuss with living kūpuna whether they wanted to submit descendancy documents. They said that they did not wish to submit any additional documentation as the submitted in the 1990s and had already been recognized. Family wants to go on oral testimony. [9:36] Hinano Rodrigues: If they previously sent in their descendancy application then there is no need to resend.

[9:38] Chair Hanapi Hirata: The family also worked with the Native Hawaiian Legal Corps so they can perhaps assist with procuring older documents.

[9:39] Crystal Cochay: She was confused and got conflicting information. She wants to know what additional information must be submitted.

[9:41] Hinano Rodrigues: He will speak with Kealana but assuming the paperwork says that their kūpuna were identified as recognized descendants, the younger generation must just provide birth certificates linking to existing identified individuals.

[9:42] Crystal – can she see the notes from past meetings?

[9:44] Chair Hanapi Hirata – meeting minutes can be accessed online at the SHPD website. She met with Kai Markell regarding records. You can request everything from Office of Information Processing. Please wait 60-90 days for a response. OIP can then issue a letter asking to follow up. NHL represented her family back then so she can also go to them about older records. [9:448] Member Soares says if he can get Crystal's email he can send everything to her

[9:49] Chair Hanapi Hirata makes a motion:

I motion to defer the rest of the applications until the next meeting [9:51] Kawehi seconds the motion, [9:51] all in favor, none opposed, motion carries [9:52]

[9:52] Hinano – this is an opportunity to take advantage of housekeeping. He recommends after deferral of an item, then say "Kealana I want this item on the next agenda" so he knows to do this. That we he can be working on the next agenda while running the meeting. Crystal also asked where burial registration and descendancy applications, use the address on the application. It goes to the O'ahu office that recieves the mail but the Maui office has no one to recieve the mail and it wil be returned. Kapolei will send it to them.

[9:54] Chair Hanapi Hirata asks about confidentiality and applicants values for privacy. She had them send directly to Kealana on Maui to keep confidentiality in align with the family's wishes. [9:57] Hinano – if you want Crystal to send it to him, then send through email so it doesn't have to go to O'ahu. He gets what they are saying about geneaology and confidentiality.

[9:58] Chair Hanapi Hirata – Please put on the agenda for the next meeting, Kealana. She was told she must do a draft agenda two weeks prior to the meeting date which then goes through the AG's office and SHPD then it comes back to them. For this meeting agenda, that didn't happen. The draft meeting agenda she created was different from the agenda sent from SHPD. Going forward she will send to SHPD Maui staff and Hinano and possibly AG.

[10:02] Hinano – we have in our budget a request for an additional Maui burial sites specialist and we are optimistic that it will be approved. Hopefully Kealana will get some more help.

V. COMMUNICATION

[10:03] Chair Hanapi Hirata – there are things on agenda she wanted to discuss but if it is not agendized how to get it on the agenda? Under communications, you can talk about things under communications or updates. If you want to make a motion it must be on the agenda, under "communications" you can bring things up to be agendized at the next meeting.

A. Status of Burial Management Plan for Iwi Kūpuna at Mapulehu, 8303 Kamehameha V Highway, Ahupua'a of Mapulehu, Kona District, Island of Moloka'i, TMK: (2) 5-7-008: 076.

[10:04] Chair Hanapi Hirata: will open this for testimony and discussion. Her update: application completed and sent to Maui SHPD. Kāhea given by Ikaika. Family responded. Task force created: members include two Moloka'i Island Burial Council Members, landowner, recognized lineal and cultural descendants. County of Maui and Ikaika Nakahashi sent a few communications. Landowner and SHPD communications did not include recognized lineal

descendants or the Moloka'i Island Burial Council. Erin Wade sent communication saying they wish to develop the property, but there are multiple issues besides the burials. Malia Akutagawa was recommended as a facilitator to meet with and document sentiments of residents of that ahupua'a. Need to do studies of hydrology etc. to protect the fishpond down stream. Maika'i loa that the landowner is willing to come to the table. She met with Kai Markell for a history of events here that he may be able to assist with. Need to develop BTP and burial management plan and put the iwi to rest. OHA has lots of legacy files on this project that must be reviewed and he will start with going through that paperwork.

[10:16] Kawehi Soares opens the floor for public testimony

[10:16] Louise Hanapi – from the East End of Moloka'i. Oral culture – they knew the Naki family and they were there from the very beginning. One of the descendants was there that night, Raymond Naki. The ancestors said – Samuel Kamakau said Hawaiian culture was an oral culture in which oral history was passed down from generation to generation. They witnessed this with their own eyes. She shares her aloha with them. It is about time they have policies and procedures. Her people can't stay out of the earth indefinitely. The county aren't the landowners, they are the people. When good people say nothing, bad things happen.

[10:19] Alapa'i Hanapi – the land was entrusted to the county because he felt the government would protect the land but they are the ones who did the work of taking care of kupuna to stop the desecration. Not sure what is happening with the County. They entrusted the land to the county of Maui and every other mayor to mālama. Lots of burials, it was the end of a war. It is not zoned for money making. He thought a zoning of no land use. The whole area is a burial ground. Confused by the changes in regime in government. Focus should be the kupuna in Mapulehu. They were the ones who did the mālama. Wants to see something pono. Insulted by the county.

[10:22] Vice Chair Kawehi Soares closes public testimony

[10:22] Chair Hanapi Hirata:

Wants to agendize: Malia Akutagawa said write a letter regarding land parcels surrounding an ocean area with beach access known to the bay owned by Moloka'i Ranch. Wants to communicate with OCCL and Moloka'i Ranch. Mentions TMKS. To open lines of communication regarding management plan for previously re-interred iwi from the 1970s and also more recently.
