[10:17] (1:09:20) Ku'upua addresses the Council: Her job is to ammend the Hawai'i Administrative Rules. She outlines and summarizes the laws pertaining to burial councils as they exist today. With revisions certain things will change but this is in effect today.

[10:58] (1:48:58) Chair addresses the Council: Details her list of questions for the AG. Asks about the large landowner position, what are expenses for reimbursement for Council members and what are the procedures for that like if people don't have access to applications for descendancy or burial site registration? Are there funds for this or funds for flyers printed or access to internet? What can council members request funds for? Then asking for clarity about other state boards or commissions - for developer or large landowner, if there are two Molokai people on DHHL for example who wants to serve but one serves on Water Board for example, can the other person represent a large landowner? Can MIBC hold meetings for their geographical region outside of MIBC? Who makes the final decision? What if landowner does not want MIBC members to do a site visit? She wants better clarity on exact powers and responsibilities. Who owns the reports after MIBC requests they be created? Clarification in detail on what it means to "assist SHPD" with any part of the rules. Can they identify a particular person or cultural practitioners or historian or only organizations? Previously identified - does oral or written testimony go to SHPD first or the council? She prefers all documents to go to the Council simultaneously with SHPD not just after SHPD vetted. Wants to know what timely means.

[11:11] (2:03:30) Vice Chair Soares addresses the Council

[11:11] (2:03:34) La'a Poepoe asks for recommendations of staff regarding whether executive session is required considering the matter includes current council member

[11:12] (2:04:17) Ikaika addresses the Council: Recommendation does not include anything confidential, so executive session is not required. SHPD recommends recognition of La'a as a lineal descendant

[11:14] (2:06:02) Chair Hanapi: this descendancy claim was submitted in March of 2020. This application was just shared on Dec. 14 at 2 pm.

[11:16] (2:07:15) Ikaika addresses the Council

[11:16] (2:07:54) Applicant La'a Poepoe addresses the council: He submitted an application for an added layer of protection for their family's cemetery plot on his Aunty's property. He has no reason to suspect anything harmful will be done, nevertheless it is as an added layer of protection and for the sake of having this on record. He has a house keeping question for staff: does he need to be recused from voting as it includes him?

[11:18] (2:09:50) Ikaika: this is an AG question but if you have an ethics concern you could recuse yourself. If the other two vote it is still a majority vote for quorum.

[11:18] (2:10:27) Applicant La'a: He has no financial interest in the matter he will recuse himself.

<u>11:19 (2:11:19) Chair Hanapi opens public testimony</u>: and reminds community members to be respectful. She wishes to open it to Moloka'i people first then everyone else after <u>11:20 (2:12:17) Vice Chair Kawehi takes public testimony</u>

[11:21] (2:13:02) Palmer Naki addresses the Council: This is a descendancy application. He would like an answer if the applicant wants to identify human skeletal remains?

[11:22] (2:13:55) Chair Hanapi answers: It is a specific human burial one particular area in the ahupua'a or Pulehu. It is not the whole ahupua'a. He is a lineal descendant to this burial. He is not being recognized as the one to identify human remains in Pulehu generally, but rather he will be recognized as a descendant to this particular burial.

The sun rises in the east and sets in the west, so she will address the east first and then move to the west last. The case open the longest is Mapulehu. On the record, she wants to make sure she has the correct TMK: TMK: (2) 5-7-008: 076. Old Mapulehu Glass House. 28 years + and no resolution. Many landowners. Nothing addressed. Invite went to Mayor Victorino and Council member's office. She requests if anyone with any background help testify

[11:34] (2:26:19) Janet Six here from county of Maui. Erin Wade is also here. Thanks for SHPD sharing information.

[11:35] (2:27:19) Erin Wade: Acquisition in Dept. of Finance – property is controlled by the office of the mayor. Her department, the planning and development division, often assists Mayor Victorino's office with projects. This mayor has no agenda for the property or project site. [11:37] (2:29:11) Ikaika provides procedural advice

[11:38] (2:29:40) Chair Hanapi proposes a draft motion: I as MIBC chair would like to make a motion that MIBC send a letter to the current landowner to recommend starting a burial management plan and a burial treatment plan to start the process

[11:38] (2:30:11) Niles Kawehi Soares seconds the motion

[11:38] (2:30:24) Chair Hanapi proposes a draft motion: to start and create a task force for this area of Mapulehu outside of the MIBC meetings and the task force will be made up of two MIBC members and one to include the member whose geographical area it is to be a part of that and the landowner and the landowner can invite whoever they want to be on the task force and we would recommend any ecognized lineal and culturla descendants of the area to include generations and years and years of investigation case files and all kinds of stuff. Back then they had cutural claimanets recognized for Mapulehu. She would like them to be included but ultimately landowner has a lot of say about who they want to allow on the property. Making a motion to move progressivley forward to show things and the task force will say how far they have gotten.

[11:41] (2:34:09) Vice Chair Kawehi opens to public testimony

[11:43] (2:34:42) Malia Akutagawa – she used to be MIBC chair but often lacked quorum. She is not sure if they has discussed the current BTP. County initially wanted to make a fire station but people said aole. She wanted to work with Stacy Crivello to mālama the place. She wanted a cultural organization to take over stewardship. Uncle Billy was the first chair of the MIBC. He said reasonbile thing would be to put a thick layer of soil to the iwi. Constant exposure of iwi to wind and rain. Put one thick layer of soil – wrap burials with kapa. She has shared with Chair Hirata's parents the cultural process she recommends. They were open to this but not sue if they still. Knowledge of wahi kūpuna and iwi kūpuna to take over stewardship – spoke with council person over the phone and she said she would be open to that. Mahalo

[11:46] (2:37:58) Crystal Cotchay and Palmer Naki – adds on to what Malia was sharing. Keo with Uncle Hanapi and Aunty came to him and his family five years ago and somehow they got permission to go to this ahupua'a to mālama iwi and he and his family went into this place to clean and take care but something happened along the process where they never like them there. Instead of arguing they decided to leave and decide next move. He wants to go and continue what he started. Him, Uncle Hanapi, Aunty, his father and him. Cleaned up road, cut down trees, took trees off the roof, couldn't do anything with the glass house as it isn't safe. He wanted to add on to what Malia said. He wanted to chip trees and put chips and mulch and flower sbut they stopped.

[11:48] (2:40:31) Mahina Poepoe – she supports both motions. It is long overdue action and also she is happy to see county on here. She works for County Councilmember Keani Rawlins-Fernandez but she is tesitfying on her own behalf. First time they have had a county archaeologist and she is doing amazing work

[11:49] (2:41:24) Kai Markell – like what was shared with the Chair, Malia, and others, it has been festering for 30 years. Lots of kaumaha. Thanks Palmer for his testimony. This is a situation where we must reconstruct the history and share with the working group what transired. There are burials that we disinterred and also reinterred. There are reburial sites. We must be sure where those are. Original violation with Eleanor Osborn who ordered workers to till iwi into the soil. That is why there are so many fragments. Subsequent actions pulling out plants and shade polls, kūpuna sucked into the cement of shade pole. They buried the cement with iwi somehwere. Probably iwi in the well or pūnāwai. Either we can screen everything and still won't get iwi, or just cover it and make it pa'a and decide what will grow on top or how to demarcate. When discussing duties to inventory burial sites – department mandated to inventory burial sites. A time to heal and kāko'o to mālama the iwi. And note on Council – you can close meeting to deliberate on location and description and close to the public. Executive session is totally different. Can consult with lawyer, HR, etc. Be careful with terms.
