**A. Discussion on O‘ahu Island Burial Council membership, roles, and responsibilities**

**Information/Discussion:** Discussion on the above items.

*Summary of discussion follows, below:*

inquiry on current OIBC vacancies and applications received by Boards and Commissions to fill the vacancies

Programmatic Agreement for Ala Wai Watershed – Chair Ehrhorn asked Regina K. Hilo (SHPD) to invite an archaeologist from the Army Corps to attend the meeting and explain the project as well as the stipulations in the Programmatic Agreement

Kahana inadvertent and discussions with the descendants

Mike Lee mentioned the iwi at Hoakalei, which included a lei niho palaoa, and that it took 10 years for the iwi to be reburied; need to coordinate with Kim Kalama on access for descendants

Kahala Motoyama mentioned that actions at the Ala Wai as part of the Ala Wai Watershed Programmatic Agreement will affect Manoa; recommended getting a soils report from Katie Kamelamela who provides a thorough summary of her work and findings of Manoa soils in the Ala Wai

Kali Fermantez stated that he talked with “Naaupo” [the individual who called the news station to report the iwi at Kahana, which was subsequently filmed and presented on the local news]; Kali shared the broader context of what happened at Kahana and the involved parties at Kahana with Naaupo; Kali supports the SHPD’s position

Mana Caceres mentioned the three vacancies for the Oahu Island Burial Council and urged the public to reach out to their communities and ask individuals to apply to fill the vacancies

**Discussion/Determination:** Discussion and determination to recognize the above individual as cultural descendant to unidentified human skeletal remains at the above project.

*Chair Ehrhorn read the above item onto the agenda*

*Kahala Motoyama and Punahale Motoyama sat at the table; Kahala Motoyama provided testimony, summarized below:*

Kahala thanked Kaanohi Kaleikini for blazing a path; Kahala can walk to the location where the iwi were discovered in 10 to 15 seconds from where she lives in Manoa; she is concerned that the cemetery is close to First Hawaiian Bank; she is happy that the council Chair mentioned and discussed the Ala Wai [Watershed] Programmatic Agreement; Manoa Valley Theatre is on the exact location of the former chapel; names of families buried in the cemetery are: Woolsey, Koani, Kaeo, Silva, and Ordenstein; in the 1830's, over 300 people were buried there, though maybe the iwi has been washed away; Manoa Valley Theatre refreshment bar was built over Kahala's great-grandmother's grave – she was disinterred, as Kawaihāo council Portnoy had her moved; Kahala has concerns about doing this right; in the 1950's, East Manoa Road was widened, so there was pushing and shoving of soil, possibility that these iwi were impacted by those actions; her concerns are the Council's practices, as Kahala has read Kaanohi's case and knows what rights were won; Kahala stated that she is not anti-business; 1) iwi found on different places on the property, 2) concerned about the areas in between, and 3) the anticipated levels of ground disturbance; wanted to ensure the Burial Treatment Plan being developed is respectful to kupuna; is concerned about the building being demolished

*Chair Ehrhorn asked if the Burial Council members had any comments;*

Mana replied, stating that the kuleana to mala iwi is a family kuleana, therefore decisions should be made as a family

*Peter Gonsalves provided testimony, summarized below:*

Ohana name is Opunui, lived in Manoa as a child, played in the graveyard, lived on Woodlawn; moved to Kaneohe in 1966; Opuhui ohana lived in Manoa for a long-time, they were descendants of Princess Kahanu, and the descendants are buried there; Peter stated that he is before the OIBC to represent his ohana and ensure the BTP will protect the iwi; he is a retired firefighter; Peter has 12 years of precision aerial photography for litigation and history experience; he knows of another project abutting the graveyard

Chair Ehrhorn opened the floor for comments; comments from:

Kahala Motoyama – Agnes (Neki), herself, and Peter are all born and raised in Kolowalu; Neki – born in the family home where Safeway is now, knows the cemetery; concerned about the iwi

Chair Ehrhorn stated that cultural descendants are representatives of the iwi

Council Member Fermantez said 'mahalo' to Peter, Kahala, and Neki, as they are born and raised in the project area

*Summary of testimony follows, below:*

Dawn: following OIBC meeting on July 13, 2016, the project proponents met to discuss comments and recommendations from the meeting; brief summary of the AIS and supplemental AIS – extensive fieldwork, 340 trenches, 3 burials: 7288 – Test area B, shallow, scattered remains, subject to tidal inundation; 4488 – Test area C, isolated toe bone, in an area where remains had been discovered before; 7289 – Test area D, probably flexed position, in an area with floor and possible habitation

July 2016: Dawn met with the Kahuku Burial Committee (KBC) and Turtle Bay, KBC recommended that 7289 be preserved in place, establish a burial preservation area/reinternment location; 4488 toe bone be reburied with the other iwi recovered from that area; 7289 disinter and move to established reburial area

BTP has not been prepared yet; consultation with SHPD; robust mitigation plan including preservation of trail; plan on coming back in the future with a full BTP

Trever: presenting project on behalf of the project proponents; excavations approximately 0.6-0.9cm below surface (cmbs) for bioretention areas; LCA 10806 – Kamehameha; LCA for Keohokalole; previous burials: -04097, relocated to Halia Aloha, -7606 buried in karst cavern along Date Street; AIS under review at the SHPD; BTP in preparation; funded to begin construction in 2017, lasting approximately 18 months; excavation at deepest point is 3.4 ft. below surface

Jon: developing testing strategy; initiated consultation with recognized descendants; comprehensive testing strategy, though utilities are active and trenches may need to be realigned; pre-planning and investigative stage  
Council Member Fermantez asked who the recognized descendants included were  
Jon answered Kaanohi Kaleikini; would like to start consultation early  
Council Member Fermantez stated early and often  
Chair Ehrhorn asked what the plans for the parcel were  
Jon answered probably mixed residential, consistent with other work there  
Chair Ehrhorn asked if there were any comments  
Neki – lots of residents in Kakaako before, so lots of possibilities  
Vice Chair Mitchell asked if there were LCAs, a record of previous use  
Jon answered there were no LCAs, and the previous use was for salt

PowerPoint presentation

All burial remains can be preserved in place within a landscaped area; investigation of soils and possible buried feature; USDA soil classification: TCC (Tantalus silty clay loam) and Makiki Stony Clay Loam, boulder colluvium

Project affect to springs at Manoa; Moiliili Karst; Mr. Chester Lao – head hydrologist from Board of Water Supply, stated that it doesn’t appear the project scale and location will affect

springs and water flow; 7 borings done for geotechnical survey; next steps for AIS – Section 106 MOA: 1) architectural mitigation, 2) supplemental testing, 3) archaeological monitoring, and 4) burial treatment plan

Archaeological monitoring plan

BTP – if iwi found during demolition, becomes previously identified, therefore jurisdiction of OIBC

Kahala: concerned about the landscaping in the BTP

Yuklin: who are the signatories for the MOA?

Matt: FDIC, SHPD, FHB; cultural descendants are consulted as well

Vice Chair Mitchell said ‘mahalo’ to CSH osteologists and Kaanohi and OCR for their hard work

2013 Annex: potential for more materials to be present

Herb Chock, Waiālae Country Club: project is limited to the green wall lines (map distributed), as there is only an expansion of office; trees in red will be removed; orange indicates new landscaping, tree installation, which will require ground disturbance

Consultation started with descendants and with OIBC

Chair Ehrhorn asked about the burial preserve area

Liz stated it was under the building

Council Member Caceres stated he and his family participated in reburial; in situ, preserved in place

Council Member Holck asked about access

Liz stated there was not access

Chair Ehrhorn asked if preservation in place was done by redesigning the elevator

Liz stated yes

Chair Ehrhorn asked about the other reburial locations

Liz stated 7207 was on the clubhouse grounds; 7206 was relocated to 7207.

Council Member Fermantez asked when the Fitness Center construction took place

Liz answered 2013; 7207 is a planted area, with a vault, underground

Morgan stated the consultation with descendants and SHPD will continue

SHPD Archaeology branch chief Susan stated the soil testing strategy was developed with the SHPD

Morgan stated AIS for the footing areas  
Kaanohi stated she wanted to see the contact correspondence

Morgan stated it as back in December, and wasn't sure who did it

Case-by-case basis

Kaanohi: would support Yuklin's request

DPP, Kihei – Consensus needs to take place

Dawn: presumption is preservation in place, case-by-case treatment; at the end of the day, who is going to malama the iwi? Take Vice Chair's recommendation to consult.

Vice Chair Mitchell recommended consultation

Dawn: guidance from OIBC is consultation with recognized descendants

Susam: recommends consultation; if consensus is preservation in place, then AIS would stop

Dawn: incomplete AIS fieldwork, no AIS, no BTP

Chair Ehrhorn stated first step is consultation with Kailua group.

Yuklin stated she is not a developer

Kaanohi: since AIS has started, it should be finished. This is not the appropriate time for consultation.

Dawn: hearing recommendations to consult. Need to find a way to finish the AIS.

AISP submitted; Multi-purpose Center removed approximately 200 tons of material; any human skeletal remains encountered will be previously identified, therefore the disposition is OIBC's jurisdiction; monthly update, 24-hour notification of any finds; Kona moku representative was previously the notification contact; AIS will be starting soon; anticipated findings: current Kawaiaha'o Church is the 5<sup>th</sup> one, previous ones were bigger; summer 1838, the current church, excavation – 78' width, significant basement excavated, with encountered burials at that time being moved, under the guidance of Kamehameha the 3<sup>rd</sup>, some not collected; AIS moving forward with no intent of moving the iwi

Chair Ehrhorn asked how soon

David stated possibly next week. Water, sewer, and electrical side-by-side doesn't work well; Church would like the excavation as minimal as possible

Greg Kodama – construction

Frank Pestana – Church

Frank: Electrical lines are where HECO requests them

Chair Ehrhorn asked why not move the waterline

Frank: no connection

Chair Ehrhorn asked about microtunneling

David: explored, but not a viable option and not supported by the Native Hawaiian consultants.

Alani: Microtunneling, if board has been approached, but not aware of the context, then likely going to Point B from A is done as quickly and efficiently as possible

Discussion context unknown, where micro-tunneling is done in sensitive areas, you still require large entry and exit pits

Alani: has its own set of challenges and doesn't avoid iwi issues

David: OIBC point-of-contact for notification and also how to consult if not meeting

Council Member Fermantez said 'mahalo' for the site visit. Kaumaha. Whatever OIBC can do to facilitate reinterment. Curation seems pono.
