A. Discussion on O‘ahu Island Burial Council membership, roles, and responsibilities

Chair Wong-Kalu requested Executive Session with Deputy Attorney General Linda Chow

Vice Chair Mitchell blessed the food

Motion: to move into executive session to discuss OIBC roles and responsibilities

Moved by: Vice-chair Mitchell

OIBC moved into executive session with Deputy Attorney General Chow and Amanda Weston at 10:50 AM

OIBC moved out of executive session at 11:15 AM

Chair Wong-Kalu stated the meeting agenda for August 2, 2017 was nearly identical to the agenda from July 12, 2017.

Chow stated the OIBC did not have quorum at the last meeting, therefore the agenda from July 12, 2017 needed to be redone in compliance with Sunshine Law.

Chair Wong-Kalu stated she would go through the motions again, as a formality.

Chow stated that even without quorum, a board or commission can receive testimony; therefore, testimony given at the July 12, 2017 meeting can be used to affect decisions at the current meeting

Chair Wong-Kalu thanked Deputy AG Chow for her guidance and for attending the meeting.

Lois Yamaguchi (Kawaihāo Church) asked for clarification between the agenda posted online on July 27th and the [edited] agenda distributed today.

Burial Sites Specialist Hilo stated there was an omission of a word on several descendant recognitions, which was added to the agenda with the word ‘Edited’ and distributed to the audience today.

B. Department’s Recommendation to Recognize Paulette Kaanohi Kaleikini and ‘Ohana (names attached) as Cultural Descendants to Human Skeletal Remains Encountered at Kawaihāo Church Multipurpose Building Renovation Project, Honolulu Ahupua‘a, Kona District, Island of O‘ahu, TMK: [1] 2-1-032:017

Chair Wong-Kalu read the above agenda item onto record, and followed with the language for HAR 13-300-25(d), below.

Discussion/Determination: Discussion and determination to recognize the above individuals as cultural descendants to unidentified human skeletal remains at the above project.

The Council may elect to go into executive session pursuant to HAR §13-300-25(d). The Council may close a meeting whenever location or description of a Native Hawaiian Burial site is under consideration. The chairperson, by concurrence of a majority of members present at the meeting, shall be authorized to require the public to leave the meeting while the confidential matter is being discussed and reopen the meeting once the confidential matter is no longer being considered.

Member Caceres recused himself from V, B, F, G, and H.

Vice-Chair Mitchell stated he works for CSH, though is not paid for any job on Oahu for CSH; state he would recuse himself.

Chair Wong-Kalu stated she would support the Vice-Chair’s decision to participate in his capacity as a council member.

Kaanoahi Kaleikini stated she and her 'ohana had been approved as lineal descendants at the July 12, 2017 meeting.

Chair Wong-Kalu commented.

Deputy A.G. Chow stated the OIBC must stay within the parameters of the agenda; if lineal descendant recognition was being sought, the agenda would need to list the recognition as lineal.

Chair Wong-Kalu commented.

Deputy A.G. Chow stated cultural descendant recognition is a different standard than lineal descendant recognition.

Chair Wong-Kalu commented.

Chair Wong-Kalu read the item onto agenda, invited applicant to speak

Kaanoahi Kaleikini stated she had submitted the descendant application for lineal recognition previously to the SHPD; the recognition done on July 12, 2017 was incorrect; requested to withdraw the item from the agenda and will submit an application for lineal descendant recognition

Hilo stated she looked forward to the application

Item was withdrawn from agenda

C. Department's Recommendation to Alexander L. Akau, Elaine M. Akau, and J. Mahealani McClellan as Cultural Descendants to Human Skeletal Remains Encountered at Kawaihae'o Church Multipurpose Building Renovation Project, Honolulu Ahupua'a, Kona District, Island of O'ahu, TMK: [1] 2-1-032:017

Applicants Alex Akau and Elaine Akau presented testimony

Summary:

Alex Akau and Elaine Akau – names provided of individuals who were buried in the family's plot included: Ioanei Ii, Ii, Stevens/Stephens, and others; provided photos of headstones for OIBC members to view

Member Fermantez asked if the applicants had consulted with the SHPD

Akau stated he only talked with Hilo yesterday; discussed Burial 95 in the walkway with the lane

Member Fermantez asked what happened to the headstones

Akau stated he did not know what happened, that applicants must now put a name to a number; descendants; Jane Lawler Trask, wife of Arthur Trask, who's first husband was [Hilo to retrieve name from recording]; John Lipini Fern of the Davenport family from Kohala; Townshend and Wilson; Captain English of Fanning Island; Akau has information that he is related to individuals at Fanning Island; photos of headstones shared were taken in 2007

Chair Wong-Kalu stated the SHPD's recommendation is for cultural descendant recognition

Hilo stated the division is working with the applicant

Chair Wong-Kalu suggested Akau consult with other individuals who are well-versed in recognition processes; option is to take the division's recommendation or return later; taking

recognition now will afford consultation to the applicants; withdraw recognition request to pursue lineal descendant recognition and return later

Kaanohi stated the descendant came to the Council to be approved and shouldn't be shamed in front of the Council and community

Chair Wong-Kalu stated the issue is better resolved between division and 'ohana; important to communication between division and applicant; requested the division indicate to the SHPD on the appropriate recommendation

Akau asked if the same application could be used

Chair Wong-Kalu replied affirmatively; division needed to indicate the applicants wish to be recognized as a lineal descendant

Vice-Chair Mitchell stated he felt there was mistrust and/or miscommunication between the applicant and the SHPD

Kaanohi stated discussions with the SHPD were always in person; not the division's kuleana to carry the applicant's kupuna.

Chair Wong-Kalu stated Kaanohi's comments had been noted.

Bill Haole (Kawaihāo Church) asked if the same information would be available to project proponents in order to support an applicant's submitted information to substantiate a lineal claim

Chair Wong-Kalu disagreed; applicant can move into executive session [to discuss with Council]; it is at the applicant's discretion and/or the public's discretion to challenge a recognition; during consultation with individuals who are recognized, those sentiments can be shared; family may have information and may not wish to come to the Church; goes two ways; uncertain intentions; supports applicants' initiative to come forward.

Bill Haole asked for clarification on lineal descendancy criteria being used to determine a lineal descendant standard has been met

Chair Wong-Kalu asked that when Kawaihāo's Legal Counsel comes to the OIBC the Council be notified.

Bill Haole stated he believed that happened previously.

Comments from Member Amaral.

Lois Yamaguchi stated it would be more efficient to have information available ahead of time.

History and Culture branch chief, Hinano Rodrigues, stated Sunshine Law does not provide the division and the project proponents time to react to the agenda; cautioned everyone that genealogical information is not shared, is kept confidential; applicant can come before the Council and share their genealogical information in executive session.

Chair Wong-Kalu read HAR 13-300-25(d) onto record; genealogy is also protected by HAR 13-300-25; malama iwi kupuna falls under kanaka worldview; information does not preclude a project proponent's ability to engage an applicant; follow the process as it is important.

Hinano stated the division will not provide genealogical information, as a lot of what the division does is based on trust.

Guest stated there is a box on the application

Hinano stated there is a box to allow sharing of information, near the signature line

Chair Wong-Kalu stated the applicant needed to ensure themselves that is what the applicant wished to do.

Kalehua Caceres asked a question about project proponents and cultural descendants

Chair Wong-Kalu requested the SHPD articulate to the rules that this is the practice.

Chair Wong-Kalu called Linda Chow at 12:50 PM; asked about HAR 13-300-25; section (d) addresses IBC confidentiality and descendant genealogy; 13-300-04(1) (C); Deputy AG Chow requested Hilo send an email requesting clarification

Bill Haole stated the question was regarding (sharing of the) name of the grave/burial being linked to (for lineal descendant recognition)

Deputy AG Chow stated the name being linked to should not be confidential; location of the burial should/can be confidential.

Kaanohi stated the name and location of the burial is important to know.

Deputy AG Chow stated the Church has a right no know.

Vice-Chair Mitchell asked why the Church does not go directly to the family/families

Bill Haole asked about lineal claim(s) to a project rather than a parcel

Kaanohi stated recognition is to those being disturbed within the footprint of the building, not those outside the footprint
