#### **Summary Paragraph**

The Henry Hattie residence is a rectangular one-story, plaster-on-lath, double-wall wood frame structure. The single-family dwelling was built in the Greek Revival style characterized by its pronounced gabled covered entry porch. The entry porch is defined by the Tuscan style columns with Doric capitals at the front end, and rectangular shaped pilasters at the front wall of the home, supporting a pitched gabled roof with a cornice line embellished with a wide band of trim to emphasize the Grecian temple-like roof form. The plaster on lath walls are scored to resemble stone and are enhanced with a faux finish of cut limestone or travertine. The house is located in Waikiki near the intersection of Diamond Head Road and Poni Moi Road and is part of the Diamond Head Terrace Tract development. This house has good integrity of design of Greek Revival style. This property is in good condition and stands out with its bold Greek Revival style features among the rest of the historic properties within the same neighborhood, the location, setting, materials and master level craftsmanship create a residence with a powerful presence.

The Henry Hattie residence, built in 1927, is located as part of the Diamond Head Terrace development of quaint bungalows of varying styles developed in the 1920s and 30s. The single-family home stands on a 4,675 square foot lot off of Diamond Head Road, and faces northeast towards the street, within walking distance to Kapiolani Park. There is a six-foot tall rock perimeter wall separating the property from the street and south neighboring lot. On the remaining north and east sides of the area, a chain link fence serves as a border.

The front and sides of the lot are laid with concrete and serve as a parking pad, driveway leading to the single car garage at the south corner (144 square feet), walkway/utility area and rear patio. Green space and landscaping is found on the front north corner of the lot and beyond the concrete patio in the back.

The residence is a one-story, 1,481 square foot, rectangular, double wall, wood frame structure. The house has a post and pier foundation. A perimeter wall conceals this post and beam structure and is thick to appear as though a thick two and a half foot high foundation stone base is supporting the Greek Revival structure. The architectural style is Greek Revival, character defining features being the roof and entry porch.

The statement roof is a hip-on-gable form with the ridge running north south parallel to Diamond Head Road. It has a gabled pediment and a dramatic twenty-six inch soffitted overhang complete with stepped cornice molding. The roof is sloping approximately 4:12 and roofed with asphalt shingles. The frieze holds as arched opening highlighted by scored stucco frame in the shape of a roman stone with a center Key Stone.

The exterior material, covering all elevations, is lath and plaster. The plaster is scored and its face is grooved individually by hand to look like limestone or travertine. Each "stone" is one foot in height and varies anywhere from three and a half to four and a half feet in length. All of the windows and doors are highlighted with a six and a half foot wide by one inch deep plastered and scored frame to match the exterior wall finish.

The full height entry porch is arranged on the center of the main façade elevated on a platform and accessed by three broad steps ascending from the front parking pad. The porch is on the front facing Diamond Head Road. The full height roofed entry porch faces Diamond Head Road. The base of the porch is a one foot six inch thick concrete platform with three six-inch tall, wide steps that descend from the front. The porch is topped with a triangular pediment, on the gable end, with a two-foot soffitted overhang. The stepped cornice molding around all sides of the roof and gable end creates a deep frieze, detailed with an original arched multi-pane window in the center of the frieze. Two identical pilasters support the back of the pediment where it meets the wall of the main façade. Paired Roman Tuscan style columns with Doric capitals support the pediment in the front. The columns are made of lath and plaster with a smooth finish, setting them apart visually from the grooved texture of the exterior walls. The column shaft is larger in diameter at

the base and decreases gradually towards the top. The Doric capital is nine inches in height, and the base is thirteen and a half inches tall. Each column is handmade, evident by the imperfections seen when examined closely. The ceiling of the porch is covered with large square tiles. The white washed pieces are identical with detailed plaster molding motifs adding to the grandeur of the entry. The entry door with side lights is centered on the porch, adjoined by a rectangular, grooved, lath and plaster frame surround and is flanked by two matching sets of windows.

Windows are spaced at regular intervals along the perimeter of the rectangular floor plan. All of the windows are double-hung, most measuring two and a half feet by 5 and half feet. Bathroom windows are smaller and set higher in the walls. There is a rear door off the center hallway exiting to the grassy lawn in the back.

#### **Interior**

The 3007 Diamond Head Road residence is laid out in a traditional way with public spaces in the front of the house and private spaces located in the back of the house. The living room and dining room are located next to each other in the front. From these two public rooms, a central hallway stretches to the rear entry door on the opposite side. The kitchen and laundry room are located adjacent to each other on the southwest corner of the house. The master bedroom is located behind the dining room on the north side of the hallway. The master bathroom sits in the northwest corner of the residence and is the only bathroom in the house.

The living room serves as the welcoming area into the home as it is the first space through the double entry doors. The space has original baseboards lining the ground level and carpeting is currently covering the original wood floors. Windows on the east and south walls fill the space with natural light and breezes.

The dining room is located in the front of the home next to the living room with two sets of windows and a large double closet with mirrored glass doors on the west wall. The kitchen is one of the largest rooms in the house with two doorways, one leading to the central hallway and one leading south to the laundry room. There is one large set of windows centered on the back wall of the kitchen, above the sink, overlooking the back yard. The floors are newly updated tile. The laundry room pantry is tucked in the southwest corner of the house off of the kitchen. There are two sets of windows and one rear door leading to the backyard. The flooring is updated tile.

The bathroom, directly across the hall from the kitchen, is located on the northwest corner of the property next to the master bedroom. The master bedroom is adjacent to the bathroom in a simple design with one large window on the north wall and full closet.

Integrity

The exterior of the home has high integrity of design (especially in regards to its exterior form), location, setting, materials, workmanship, association and feeling. This home is in good condition. This residence has continued to be used as a single-family residence since it was constructed in 1927. The interior of the home has been updated over the years and the details, such as windows and doors, have been replaced, but the locations and sizes have not been

altered. The unusual hip on gable roof and full height entry porch add to the integrity of the property contribute to its character and historical value.

**Statement of Significance Summary Paragraph** (Provide a summary paragraph that includes level of significance, applicable criteria, justification for the period of significance, and any applicable criteria considerations.)

The 3007 Diamond Head residence meets the historic register criteria C. Architecturally; this house is of artistic value and reflects the Greek Revival style that is not often seen in Hawaii in the 1920s and 1930s. It holds distinctive characteristics of a type, period, and method of construction. This house is significant at the local level for the period of 1927 when the lot was purchased and constructed by Henry Hattie.

#### Criterion C

The residence is significant under criterion C as it is a rare example of Greek Revival style constructed in Hawaii during the early to mid 1920s. This style of architecture is not common on the island and is even more exceptional to see as a private residence. The property is recognizable as Greek Revival because of the large cut block exterior, hip on gable roof, heavily emphasized cornice lines, the column supported full height entry porch, and the one story rectangular floor plan.

The Greek Revival style is an American architectural style that is most often seen in the northeasters and east coast states and was most popular on the mainland during the mid 1800s. The style is still prominent today in historic cities such as New York, Pennsylvania, Virginia, Georgia, and many other states.<sup>1</sup>

One of the earliest representations of the Greek Revival architectural style in Honolulu was the Court House on Queen Street (demolished), built in 1852, that was designed by William Brandon. When it was built, the former court house was one of the largest buildings in the city and appeared even larger due to the heavy masonry coral block, pediment front gable, pilasters, single story entry porch, and Doric columns.<sup>2</sup>

An example of Greek Revival style architecture that is still in existence today is Queen Liliuokalani's Home, Washington Place. Today, the structure is used as a museum and formal reception hall. This building was constructed in 1847 and is a prime example of Greek Revival architecture with key features such as shallow hipped roof, single story entry porch, Doric columns, and stone block exterior.<sup>3</sup>

This property is a simplified, more modest, take on the Greek Revival architectural style, as applied to a residence. The features of the residence that is in keeping with the style are the low pitch gable-in-hip roof with dominate cornices and wide overhangs, cut stone wall material, symmetrical façade, and single story central entry porch with columns.

The 3007 Diamond Head Road residence is an example of the Greek Revival Style in Hawaii and carries the defining features of the style in a smaller scale. This residence reflects a style not often seen in Hawaii, and stands as part of the original buildings constructed on the Diamond Head Terrace Tract just south of Waikiki.

This property is significant under criteria C because of the significance of the style it was built in, the time it was built in, the materials used, the integrity it holds today and the workmanship. The Greek Revival style is not often seen in Hawaii – even more rarely seen using materials that are not stone. Rather, this building was constructed using plaster on Lath that was individually scored to look like stone. The craftsmanship is master level with hand cut grooves on the exterior and columns on the front porch. The character defining features of this home and hand cut detailing work come together to make an architectural masterpiece deserving of recognition.

#### **Previous Owners**

The original owner of this lot was Isabella Woods who sold the lot to Henry Hattie in 1937. Henry Hattie was born on October 5, 1896 in Kohala Hawaii. His father was an immigrant who came to Hawaii from Nova Scotia in 1869 and his mother was of chinese decent, born in Hawaii. Hattie married his wife Prudence Eliza Abbey in 1924 in Mount Vernon, Washington. After they married, the family relocated back to Honolulu Hawaii. Hattie purchased the 3007 and 3001 Diamond Head Road lots from two different owners (Robert Crockett and Isabella Woods). Hattie purchased the 3001 Diamond Head Road property in 1937. He purchased the neighboring lot, 3007 property, a little later in 1941. After the purchase of the 3007 property, Hattie combined the two lots into one – with a house on each. After Hattie died in in June of 1977, his wife Prudence acquired the property and remained the owner until 1978 when Clifford Mirikitani Sr. purchased both properties at the same time. Today, Mirikitani's son, Clifford Mirikitani Jr, owns the two homes.




Figure 2: Current Tax Map Showing Property Boundary and Location







Figure 4. First Floor Plan










