#### I. CALL TO ORDER

Chair Wong-Kalu called the meeting to order at 11:24 AM, and thanked the OIBC members and meeting attendees for coming to the meeting.

Chair Wong-Kalu commented in Hawaiian, then offered pule in Hawaiian

OIBC members introduced themselves in the following order: Chair Wong-Kalu, Vice Chair Mitchell, Member Caceres, Member Mills, and Member Ehrhorn

RKH introduced herself; her intern, Correna Knight; and introduced Andrew McCallister, the new Oahu Island Archaeologist

## Summary of discussion:

Chair Wong-Kalu shared that Beverly Amaral, the Ko'olaupoko Representative, is no longer able to serve on the OIBC due to a family emergency; Chair asked that RKH contact her after April 21st to discuss next steps

Chair shared that there are only Kali Fermantez and Lurline Naone Salvador on the Council [with Beverly now withdrawn from the Council] in addition to the 5 members present at the meeting; with an attendance of 3 or 4 Council members at a scheduled OIBC meeting, there will not be quorum and therefore an informational hearing/gathering may be held but no business may be addressed. There is no longer a cushion of additional members.

Chair mentioned to Kali Fermantez that if his duties carry beyond what he is able to redirect and shift to accommodate the meeting, he needs to notify Chiar right away; stepping away is not a problem at all; Chair wants an opportunity to take any replacement names over the governor's office for appointment of an immediate replacement; goes with much aloha for those who volunteer to do this work.

Fermantez had indicated to Chair that he was already overwhelmed.

Replacement Council members are needed for Koolaupoko [which was held by Bev Amaral]; Large Land Owner [which was held by Danna Holck]; and most likely Koolaupoko [which is currently held by Kali Fermantez]

Chair mentioned that if there were no ideas for a third Large Landowner Representative, the Council will double-up on a Kona Representative, as there are a lot of strong cultural people in Kona.
