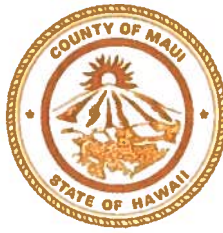

At its advertised public hearing on July 3, 2019, the Cultural Resources Commission (Commission) reviewed the nomination of the Mary P. Bright House to the Hawai'i Register of Historic Places. Copies of the staff report to the Cultural Resources Commission and the subject nomination are attached for your reference.

The Commission found that the Mary P. Bright House meets the criteria for nomination and recommended that the property be entered into the Hawai'i Register of Historic Places with the minor amendments provided by staff at the July 3, 2019 hearing.


