Ms. Peacock stated that in your written description there are no google maps or site plans. The beach façade is important in terms to the presentation to the public. What you don't see and cannot see unless you've been to the site. Is that there actually a modern house on the Makai side. That blocks the access visually of this house. Not that you could see this house even if there was another house that was put on the Makai side because of the in infrastructure of these columns and the large solid walls that are slicing within a foot or two the of the house. When i looked at the original plan its seems to be a lot of modification to the house in the wing of the house. I guess the owner decided to flip the plan. In the original site, there is a lot of growth in the bedroom wing. They increased the square footage of the house, in the original drawings it's a stager between the garage and the bedroom wing. It doesn't match the architect original drawings. And begs the question was that the architect's intentions. And the entry sequence is different.

Mr. Hibbard stated that its not growth they modified they took out a bathroom.

I think that it was done originally. The walls are original. When they flipped it, the must have done it cause there's no way that's not original. The plans that i have obviously got modified because they flipped it.

Mr. Casen asked Ms. Peacock- you said that there is another house on the Makai side. Is it on the same lot?

Ms. Peacock yes, it's on the same lot. I think a google map, if not a site plan would help. It's hard to see and understand the complexity of what's going on in this site that is not conveyed in any of these photographs.

Mr. Hibbard responded it was the only reason they changed their plans because we said this is an important property and should be saved.

Ms. Peacock responded but if they were to remove all this stuff, then come and apply why would that not work?

G. COMPLETENESS OF NOMINATONS

Mr. Downer: When policy affects groups of individuals broadly, instead of one or two people then it must be adopted in regulation. A Hawaii administrative rule must be written. Then you have to go through the process. If you make any changes to the draft, as a result of comments you have to start the whole process again. As long as it is a direction to staff then it does not have to be a regulation. See Chapter 13-198-3: Nomination procedure. "The preservation officer, or any person or agency may nominate a building, structure, object, district, or site for entry into the Hawaii register. Nominations shall be made on the standard national register nomination forms, available in the office of the preservation officer, in accordance with the technical guidelines for the completion of those forms". The board agrees that locally submitted nominations will be held to National Standards.
