Chair Chapman and Lim will be leaving the Review Board at the end of the Fiscal year (June 30, 2016). Vice-Chair William Souza will still be on the Review Board. Administrator Downer reminded the Review Board that Sunshine Law prevents the members from talking about voting.

#### D. SHPD REPORT

Borthwick talked about the Preservation Month Calendar being posted and shared. This will be a way to bring attention to organizations and the type of work they do.

May is National Historic Preservation month. SHPD is spreading the word about it on its website.

2016 is also the 50<sup>th</sup> Anniversary of the National Historic Preservation Act.

19 February 2016 Hawaii Historic Places Review Board Meeting

2016 is also the 40<sup>th</sup> Anniversary of Chapter 6-E.

The SASH started this week on Kauai. Four to six neighborhoods on each island are surveyed for styles, condition, and special features. During March and April, the SASH will be on the Big Island. Then on Maui. The survey will be done by Fall 2016.

Souza inquired about the SASH visits.

Broverman scheduled sites by talking with CLGs, community organizations, mayors, members of the public, etc. for those that defined residential neighborhoods. This project has had a lot of public support. Kauai has lots of information about swinging bridges. A radio show on Kauai reached out to DLNR, and there was an excellent response from the public. The Garden Isle newspaper has also put out positive press. SHPD is working with West Hawaii Today as well.

Administrator Downer also mentioned the DLNR Press Releases that have been put out recently.

Grant \$57,000 per year?

Senate Bill SB2157 Funds to study reflecting pond at the State Capitol.

Sunshine Law is a separate item on the agenda.

Awaiting Governor's Nominations for Morgan, Griffin, and Okinaka. Expects to see something later in the Legislative Session.
