#### **Summary Paragraph**

The Cosmopolitan Saloon is located at the corner of Nuuanu Avenue and Hotel Street, along the eastern boundary of the Chinatown Historic District. To the west of the building lies Chinatown, which is characterized primarily by one-to-four story commercial buildings, while to the east are many high rise office and apartment buildings. It sits on a flat, 3,497 square foot lot. The single story commercial style building is characterized by an east facing corner entry and has two, parallel, corrugated metal gable roofs, hidden by a paneled brick parapet with a copper cap. The rectangular shaped, brick and CMU wall building has a shed roofed corrugated metal canopy, with a decorative, jig sawn edge, running down both street-facing facades and sits on a concrete slab foundation. The 3,452 square foot commercial building is in excellent condition and retains its integrity of design, materials, location, setting, workmanship, feelings and associations.

#### **Narrative Description**

The Cosmopolitan Saloon features a corner entry from which the building extends down both Hotel Street and Nuuanu Avenue. The corner entry has a double door with a single pane transom above, and opens on a shop. The shop has in both its northeast and southeast walls two boxed, single pane display windows with single pane transoms above. All the street facing windows and doors in the building are not historic. On the interior the shop has been remodeled. It has a dropped ceiling and a plywood floor, and a storage space with dry wall walls projects out from its west corner. A portion of the southwest wall's original brick wall is exposed, while the remainder is under its historic plaster finish. A non-historic, two pane, wood frame door in the southwest wall opens on a hall.

A second shop is to the northeast of the corner shop and is accessed through a door on Hotel Street. To the northeast of the door are two box windows similar to those in the corner shop. This retail space is vacant and has a concrete floor and a dropped ceiling. A portion of its original northwest brick is exposed, while the remainder is under its historic plaster finish. A doorway with no door in it southwest wall opens on a recessed storage space with brick walls. To the northwest of this door is an original six pane casement window with obscure glass, which looks into the storage space. To the southeast of the doorway is a modern two pane, wood frame door which opens on the hall.

Along the Nuuanu Avenue façade, to the southeast of the corner shop, an opening with a metal gate accesses the hallway between the southeast office and northeast shops, and southeast of this is a two pane, wood framed door which is flanked by single pane windows on either side. The door and windows have single pane transoms. The door opens on an office. The office has been remodeled. It has a dropped ceiling and a plywood floor with a paper top finish. The southeast, southwest and northwest walls of the office are of brick, which retain their original plaster coating. On the southwest side of the office the room extends to the rear of the property, and in its rear, northwest, brick wall there are two ten pane, industrial steel windows with fire glass in their panes. A new wall bisects the northeast-most window, with half in the office and the other half in a men's restroom. On the northeast side of the room the floor is elevated two steps. Two modern, two pane, wood frame doors in the northeast wall of the office open on the hall.

The hall has an L shape, running between the office and the shops and wrapping around behind the office space. The hallway's rear wing's northwest wall has a portion of its brick exposed, while the remainder is under its historic plaster finish. Two doors in the northwest wall open on a men's and women's room. They both have concrete floors and ceilings and brick walls. The men's room features half of the industrial window, which is also in the office. The women's room has no windows. The wall opposite the restrooms is lined with storage closets with modern doors.

A Tax Act project in the 1980s, the Cosmopolitan Saloon retains its historic integrity, despite the fact that much of the interior has been remodeled. It retains most of its original walls, although a portion of its façade collapsed prior to the building's rehabilitation in the 1980s, and was rebuilt in places with CMU. From the exterior the CMU is not visible due to the first story walls being completely plastered. As part of the rehabilitation the original door locations and fenestration were restored. The building retains its historic foot print and configuration, as well as its brick parapet and reconstructed façade and replacement in-kind canopy.

**Statement of Significance Summary Paragraph** (Provide a summary paragraph that includes level of significance, applicable criteria, justification for the period of significance, and any applicable criteria considerations.)

The Cosmopolitan Saloon is significant on the local level under criterion C, as a good example of a masonry commercial building constructed in Honolulu during the late nineteenth century. The building includes a number of distinctive features and is typical of its period in its design and materials.

The 1886 period of significance was chosen in accordance with National Register Bulletin 16A instructions, using the year of construction of the building as the period of significance.

Narrative Statement of Significance (Provide at least one paragraph for each area of significance.)

The Cosmopolitan Saloon is significant as a rare example of a late nineteenth century, masonry commercial building in Honolulu, with approximately a dozen such buildings surviving in the city. Others include: the Bishop Bank, Bishop Estate and Melcher's buildings all on Merchant Street, the Royal Saloon, T. R. Foster and Nippu Jiji buildings on lower Nuuanu Avenue, 1028-1044 and 1102 Nuuanu Avenue, Bickerton and Mendonca & Selig buildings on Hotel Street, the Friend Building on Bethel Street, the Robinson Building at King and Nuuanu, and the Perry Block at Nuuanu and Hotel. The Cosmopolitan Saloon is more modest than the others, being but one story in height. However, it typifies the commercial style of the later nineteenth century with its corner entry, brick construction and paneled parapet.

Following the Chinatown fire of 1886, which destroyed seven blocks as well as some of their surrounding areas, the single story, Cosmopolitan Saloon was the first brick building completed in the devastated area, having been built in six weeks and a day. It was owned by Walter Peacock and George Freeth, who ran the largest saloon business in Honolulu, with the Royal and Pacific Saloons also under their operation. The saloon survived the Chinatown fire of 1900, but in 1903 was supplanted by the California operated by Henry Vida, who was a member of the Territorial legislature. The California shut its doors in 1905. The primary occupant of this building during the twentieth century was the New York Shoe Store, which operated here from 1914 until 1952. The shoe store was started by Choy Hoy An, and upon his death in 1932, his wife, Choy Chang See ran the business. Prior to his death, Mr. Choy remodeled the store in 1930, installing large plate glass display windows. Mrs. Choy sold the shoe store in 1952 to James V. Kunst, who renamed it the Ka-ma-aina Shoe Store, closing the business in 1968, after opening a second store at Ala Moana in 1966. Mrs. Stack acquired the property in 1980, and rehabilitated it in 1986 under the federal tax incentive program. At the time of rehabilitation the building was in great disrepair and part of its exterior wall had collapsed. The rehabilitation brought back the design of the original storefronts.

The builder of the Cosmopolitan Building was George Lucas. Lucas (1821-1892) was born in Ireland. Prior to George's birth, his father had been one of the English guards who watched over

Napoleon during his banishment on St. Helena, and at some point after George's birth the British government sent his father and family to Australia to "take charge of the government domain there." [Builders of Hawaii, page 150] From Australia young George Lucas set sail for the gold fields of California in 1849. He remained in San Francisco and worked as a carpenter. In 1856, he returned to Hawaii, having stopped briefly in the Islands on his journey to California. He worked for Robert Lewers on the construction of the Custom House, and then established his own contracting business and the Honolulu Planing Mill, which over time grew to be the largest such enterprise in Hawaii. He did all the interior work for Iolani Palace, and also built the Ward Estate. Other major works included the Kapuiwa Bulding (National Register), no longer extant Campbell Block and all the wood work for the no longer extant Royal Hawaiian Hotel at Hotel and Richards streets. In addition to constructing the Cosmopolitan Saloon, in response to the fire, he also worked on replacing the Wing Wo Chan & Co. building, Yim Quon Building, the Holt Block and the Mendonca/Encore Saloon building as well as the building for Judge Bickerton (now known as Club Hubba Hubba).






# Tax Map


