V. INADVERTENT DISCOVERY OF HUMAN SKELETAL REMAINS

A. Inadvertent Discovery of Unidentified Native Hawaiian Skeletal Remains on March 16, 2026, discovered off North Kihei Road Near Keālia Pond, Waikapu Ahupua‘a, Moku of Pū‘ali Komohana, Island of Maui.

Notification/Discussion: At about 2:45 a.m., Monday March 16, 2026, Maui County Archeologist Dr. Janet Six was notified by The Maui Police Department (MPD) that human skeletal remains (HSR) were discovered off North Kihei Road near Keālia Pond. The MPD recovered the HSR and temporarily held them until The SHPD staff were able to respond. The SHPD's Burial Sites Specialist Leinoa Kong and Lead Archeologist April Greenberg retrieved the iwi from the Kihei police station at about 3:00 pm. of the same day, Monday, March 16, 2026. Iwi is currently being temporarily curated at the SHPD facilities in Wailuku

Additionally, pursuant to a policy adopted by the Maui Lānaʻi Islands Burial Council at its November 17, 2005, meeting, oral testimony for items listed on the agenda is limited to three minutes per person, per agenda item.

The MLIBC may go into Executive Session pursuant to section 92-5(a)(4), HRS, in order to consult with its attorney on questions and issues pertaining to the Board's powers, duties, privileges, immunities, and liabilities.

Pursuant to §92-4, §92-5(a)(8), and §6E-43.5 HRS, and upon compliance with the procedures set forth in §92-4, HRS, the council may go into a closed meeting to consider information that involves the location or description of a burial site.

Pursuant to §92-2.5(d) HRS, if a meeting must be cancelled due to lack of quorum, the present council members may elect to continue to receive testimony and presentations on items on the agenda.

A request to be placed on a burial council meeting agenda must be made with the Burial Sites Program staff at least two weeks preceding the scheduled meeting date. In addition, the request must be accompanied by all related documents. Failure to comply with this procedure will delay the item to the following month's agenda.
