JBr, a Lawyer from the State Office of Information Practices, shared the following:

Visit Oip.hawaii.gov and click on the training tab for more info and trainings. Most of which is online now. Directors will and to focus on the Sunshine Law Training and the Open Records Requests. There are quick reviews and guides that can support Directors including a Sunshine Law guide.

JBr went over the basics of the Sunshine Law:

JBr shared that Board and sunshine information including that:

- It is suitable for board members communicate in a group for a meeting that is not noticed as long as they do not discuss issues of board control or board business. Issues that are informational and not in board control are not board business. Logistics such as scheduling a meeting and staff concerns are not board business
- Agenda guidance is available on-line.
- Board cannot take up and consider items that are not on the agenda.
- Emergency Meetings Do not have to jump through the same hoops as a traditional meeting. Requires agreement of two-thirds or more of the board

JB continued to share:

Minutes must note:

- Board members present and absent
- Time, date, and place.
- Need to reflect the substance of all items discussed including who spoke, the summary of what they said. Paraphrase works. Should reflect who asked what.
- If someone writes testimony,
- Must include time stamps of all the significant events that happened.

Permitted interactions

- 2 person permitted interaction. Two persons can talk about anything including board issues, but cannot solicit favor or "horse trading".
- Limited Meeting Would allow the full group to meet as a field trip. Must video the experience.
