Discussion: Directors will stay on the board.

## **B.** March Flooding

Discussion: East side had significant flooding damage. Directors have asked to include information and pictures from flooding in Annual Report. Include both Christmas and March Storms. A lot of the damage was from trees in the watershed, many of the trees were cut trees, but there is no proof of specific location in which the trees had come from. Arryl noted that Grove Farm sustained major damage on roads and ditches from the floods in Kapaia, observed highest rainfalls in a long time. Ed noted that Smiths Gardens had a lot of damage. Jenna noted that NOAA that weather patterns are permanently changing so these kinds of storms may occur more often. She recommended that the districts could host a meeting for Kauai to share information as to what resources and processes are in place for management of waterways as well as options for the community when these events take place. Include entities that are responsible for the regulatory process (eg Army Corps). Eric made a motion to have a public meeting to discuss and share information to the community. Discussion regarding the meeting to include information and discussion on working with waterways and the regulations/permits needed especially Clean Water Act. In a discussion as to how to organize the meeting, possibly focus on agriculture producers and ensure that the meeting meets sunshine law requirements. Jenna noted that the office can share the information gained from a meeting with Oahu Army Corps of Engineers. Leonard agreed to first look at the information we have on hand to determine what kind of meeting we should have. Eric motioned to hold the previously made motion for now, Leonard Seconded and the motion was accepted unanimously. Motion is tabled for now and will be up for discussion in the future.

#### C. Annual Combined Kauai SWCD meeting

**Discussion**: Asked to hold off until after the restrictions due to COVID-19. It was discussed to tentatively have the meeting in September, add to the agenda once restrictions are lifted.
