V. Lahaina Watershed - email from Susan Kubo

- County of Maui released a Notice to Providers for development of a NRCS-compliant supplemental watershed plan environmental document in July 2021.
- Presubmittal conference and site visit were held on August 10 and 11.
- Statements of qualifications and expressions of interest were due on August 24.
- County of Maui received 7 submittals. One was disqualified because a key document was missing.
- After initial review, 3 applicants were selected for interviews, and references were checked.
- Following the interviews in September, County of Maui entered negotiations with STANTEC Consulting Services, Inc. Negotiations began in October and were finally completed in January 2022.

 On 1/10/22, Maui DPW submitted contract request documents for the project for processing. We are told it usually takes two months to fully execute a contract, but that they will try to push it through as quickly as they can. They are hoping to issue the notice to proceed in March.
