#### V. Southwest Maui Watershed Plan

Michael Reyes and Richard Sylva had a teleconference with Mike Burke and Darcy Iwashita, DOH Clean Water Branch. DOH was very pleased with progress of the plan and have committed provide funds to complete the plan. Maggie Kramp sent an invoice to DOH as requested by Mike Burke.

There are nine elements to a watershed plan. Darcy will be reviewing the plan by chapters. All modeling has been approved. The next step to the plans is the water quality monitoring plan (already being done by the Hui – Maui Nui Marine Council, TNC, others) and proposed project timelines.

## VI. Cooperative Agreements/Conservation Plans

Hannah Lutgen is currently working on two conservation plans that are not ready for board review and approval. Both plans are farm bill applicants.

There was an online conservation planning training for SWCD directors that was scheduled last week. Maggie Kramp will contact Michelle Watkins for a recorded version for those that missed the training.

#### IX. Other Business

#### A. Maui Nui Marine Council

The Maui Nui Marine Council is focusing on the Maalaea Watershed, starting with an oyster project for natural bioremediation to improve water quality.

MNMC is also working with DLNR-DOFAW on the mauka areas as it relates to fire mitigation efforts and erosion.

MNMC supports watershed plans. They can assist with water quality monitoring, and work on project implementation.

Michael Reyes developed a stormwater management plan for Maalaea. MNMC is working on two project proposals to NFWF, which stems from the Maalaea Stormwater Management. The proposal includes implementation of fuel breaks on unused roads, and monitoring stormwater, groundwater, and erosion.

Mae Nakahata recommended looking at watershed plans on a larger scale to avoid obstacles and situations that is and has been happening on the Ala Wai project in Oahu. Mae spoke to Travis Thomason, NRCS PIA Director regarding developing a largescale watershed plan for Central Maui.

## B. Ag in the Classroom

SWCD staff visited a 2<sup>nd</sup> grade class at Kahului School as part of Maui County Farm Bureau's Ag in The Classroom. The students were working on erosion control using scientific methods, which was very impressive.

#### C. SWCD Funds

Mae Nakahata thanked everyone for their support in lobbying for both state and county funds. We were able to increase SWCD funds.
