I. Meeting Call to Order, 9:01 a.m.

The meeting was called at 9:01 a.m., at the USDA NRCS Kahului field office.

II. Minutes of April 30, 2019

Mike moved to accept the minutes of April 30, 2019, seconded by Darren Strand, motion carried.

III. Treasurer's Report

The CMSWCD directors acknowledged receipt of the treasurer's report via email.

V. Southwest Maui Watershed Plan

Michael Reyes and Richard Sylva reported on following items:

- Haleakala Ranch Grazing Management Strategies, Waipualani Gulch Impact Zone
- Proposed Implementation Projects to Include Wailea and Mooloa
- John Stock, USGS will conduct a sediment Study in Kihei, which includes the Hapapa/Waiakoa area. Funding source of this study is from NFWF, in the amount of \$97,000.

Although CMSWCD received \$14,000 from DOH to assist in completing the SMWP, Michael Reyes does not want to accept any payment until the plan is completed.

VI. Rinzai Zen Mission – Flooding Concerns

Mike Silva, Michael Reyes, and James Ino attended a meeting and site visit with representatives from County Parks and Rinzai Zen Mission to address flooding issues from Kailua Gulch.

It was noted that Kailua Gulch is not maintained, causing overflows into Baldwin Beach Park and the Rinzai Zen Mission.

A master plan is being developed for Baldwin Beach Park. Opportunity to comment on the plan would be to keep flow in the gulch and the need to maintain Kailua Gulch.

Vegetation growing in the ditch, field 213-214, is also a concern. Mahi Pono need to determine ownership of the land.

A meeting should be held with Olinda-Kula SWCD and County Park and Recreation. The next Olinda-Kula SWCD meeting is scheduled for Friday, June 28, 2019.

Mike Silva has been designated to oversee this issue.

VII. Cooperative Agreements/Conservation Plans

- A. Hannah Lutgen presented a 135-acre pasture plan, located in the Maliko Watershed. It is an approved Farm Bill EQIP plan. Mae Nakahata moved to approve the plan prepared by Hannah, seconded by Mike Silva, motion carried.
- B. Kahana Stone presented a deep litter system, Korean style farming plan for a hog farm in Waikapu. It is an approved Farm Bill EQIP plan. The plan was approved by the DOH and County. Mae Nakahata moved to approve the plan with the understanding of DOH's approval in addressing prior concerns of the Central Maui SWCD board, and plan approved and signed by NRCS district conservationist and engineer. Seconded by Mike Silva, motion carried.
