- 6. Forestry producers to understand the process of getting a conservation plan through the SWCD's.
- 7. SWCD history was for the sugar producers to receive G&G while providing conservation of the land. In the past if able to comply with certain practices able to get up to \$3,000.00. As regulatory process got more involved county wanted an organization to take care of that. Currently, sugar is no longer a business in Hawaii, and more smaller producers evolved after sugar.
 - a. Concern is that smaller producers get priority over larger producers.
 - i. It was made clear that districts role is to focus on technical assistance, so producers that are creating a CTA plan will get assistance while the district staff also help NRCS with producers looking for financial assistance. Producers looking for just a CTA plan does not come secondary to NRCS funded plans, the district staff handles CTA plans.
- 8. Kona SWCD CTA process was brought up
 - a. FSI and producers create their own plan and the Kona SWCD district board approves those plans
 - b. Suggested that a TSP to write a plan and get approved by district
 - c. Question was asked how to be able to do something like what is being done in Kona SWCD with Mauna Kea SWCD?
 - i. This needs further discussion since MKSWCD has similar planning process as NRCS
 - ii. NRCS response
 - 1. NRCS reviews plans and approve if written by a TSP. TSP's are registered by NRCS and they need to be certified as a TSP.
 - a. Need to get concurrence from James Eller
 - b. Work with the NRCS State office and working down to the field office
- 9. Brought up that the SWCD's need different pathways to approve CTA plans.
 - a. Need to discuss further.
