 - It was determined that a quorum had been established.

- Reading and Approval of the Minutes from June 13, 2022
 - The board members acknowledged that the minutes from the June
 13, 2022 board meeting had been received
 - A motion to approve the minutes of the June 13, 2022 board meeting was made by Garret Hew
 - The motion was seconded by Alan Nago
 - The motion was voted upon and passed unanimously
- Olinda-Kula Maui Soil and Water Conservation District Treasurer's Report
 - The Olinda-Kula Soil and Water Conservation District board members acknowledged receipt of the Treasurer's report and it will be kept on file

- Discussion Regarding the Olinda-Kula Soil and Water District Saving Account Held at Maui Federal Credit Union
 - It was noted that the savings account held at Maui Federal Credit Union does not yield a high return due to the low interest rate
 - It was noted that if the board decides to consolidate the two
 accounts, it will mean that a board member with signature
 authorization on file with the bank will need to close the
 account, then deposit the funds in the other bank account
 - A motion was made by Clark Hashimoto to consolidate the two bank accounts to a single bank account held at First Hawaiian Bank
 - The motion was seconded by Alan Nago
 - The motion was voted on by the board and passed unanimously
 - Appointment of Executive Officers and Directors to the Board
 - Open positions:
 - Position of Director, currently vacant
 - Clark Hashimoto has spoken with Ethan
 Romanchek, owner of Maui Native Nursery and
 he is willing to serve on the board
 - A motion was made Clark Hashimoto to nominate Mr.
 Ethan Romanchek as a Director to the Olinda-Kula Soil and Water Conservation District Board
 - The motion was seconded by Alan Nago
 - The motion was voted on by the board and carried unanimously
 - o Mr. Romanchek's term will end on June 30, 2025

 - The Olinda-Kula Soil and Water Conservation District was formed on May 2, 1948 and celebrates its 75th Anniversary in May 2023.

- Mae Nakahata of the Central Maui Soil and Water Conservation
 District proposed that the celebration of the 75th Anniversary be a
 year-long, state-wide celebration to celebrate both the beginning of
 the Kula Soil and Water Conservation District and the beginning of
 the Hawaii Association of Conservation Districts
 - Ms. Nakahata stated that she would need to get approval from the Hawaii Association of Conservation Districts before proceeding with this plan so the costs could be shared and more manageable for the Olinda Kula Soil and Water Conservation District
 - Ms. Nakahata stated that her view of the celebration was that a celebration could be held on each Island with a traveling story board featuring old photos showing the early days of the Olinda-Kula board
 - Ms. Nakahata stated that some type of event could be held each month
 - Her suggestion included having a large booth at the 2023 AgFest with photos from the early days of the District and a video to run throughout the day
 - Ms. Nakahata stated that AgFest was being planned now and this would be an excellent time to coordinate with them for the booth in preparation of the celebration

- She also suggested inviting and/or working with the Governor, Senators, State Representatives, as well as the Mayor and County Council
- Ms. Nakahata stated that the Maui SWCD website could be updated so that the page for the Olinda-Kula Soil and Water Conservation District featured the old photos and information about the celebration
- Alan Nago and Garret Hew, Olinda-Kula Soil and Water
 Conservation District board members stated that they were not comfortable with holding a state-wide celebration and that they preferred a smaller, local celebration
- No motion was made at this time with regards to the type of celebration to hold; however, it was agreed that this be revisited in the next board meeting to discuss once Ms. Nakahata was able to speak with the Hawaii Association of Conservation Districts
