- o Position of Director (elected) currently vacant

## Discussion Regarding Lahaina Watershed Flood Control Project/Puamana Association Board

- o The history of the project was presented by James J. Nobriga
- Kristi Ono relayed that Susan Kubo and Sharon Sawdey, both from the Natural Resources Conservation Service (NRCS) will be the new points of contact for project
- Additional funding was discussed
  - Kristi Ono stated that it was unlikely that the County could provide additional funding unless it was part of an existing project
  - Gerald Gregory, District Conservationist, Natural Resources Conservation Service (NRCS), stated that NRCS can provide technical assistance, but most likely won't be able to provide funding unless it was added as a new project for them

- James J. Nobriga stated that the West Maui Soil and
  Water Conservation District will try to assist as needed
- Iam Swezey asked for a review of the plans
  - Wes Nohara stated that he doesn't believe the current channel is adequate to handle the flow of the stream from Lahainaluna to Puamana

- Invite Maui County to also meet to provide the latest updates
- West Maui SWCD Board meet with the Puamana
  Association Board of Directors to open dialog on their position and concerns about the channel

 Tova had no updates, but did state they are currently working with National Oceanic and Atmospheric Administration (NOAA) on current use pesticide

 Tova stated that Susan Kubo and Sharon Sawdey, both from the Natural Resources Conservation Service (NRCS) are getting involved and will be working with Millie Wagner, Maui Soil and Water Conservation District Administrator, for reporting

  District Cultural Resources Tech Notes (Worksheet)
  - The new Cultural Resources Tech Notes form was presented on screen by Gerald Gregory, District Conservationist with Natural Resources Conservation Service (NRCS)
    - Gerald explained the form, how it worked, and what it was intended to achieve
    - Kimo Falconer moved to accept the addition of this form to the West Maui Conservation District CTA (Conservation Technical Assistance) plans and to be used effect at once
      - The motion was seconded by Ian Swezey
      - The motion was voted on and approved unanimously
- Maui Soil and Water Conservation District Planner Updates by Kelly Butler
  - Kelly had no updates at this time
- NRCS Updates by Gerald Gregory
  - Local Working Group
    - Gerald said that he needed suggestions from the board members regarding how the local working groups should be conducted in view of the ongoing COVID issues, I.e., should these be conducted in-person, via Zoom, indoors, outdoors, etc.
      - Kimo stated that he felt that people were still worried about in-person meetings, but that while
