 - Cooperative Agreement held with NRCS for NWQI (C006) has completed and all reporting has been submitted

Maui Soil and Water Conservation District Conservation Specialist Updates by Kelly Butler

Poster Contest

- Kelly stated that participation for the poster contest was down a bit this year
- There were 2 categories represented: grades 2-3 and grades 4-6, with 1st place, 2nd place, 3rd place and Honorable Mention within each category
 - Winners received a certificate and a prize ribbon
 - Prizes for the winners included backpacks, gift certificates and gift cards, and other miscellaneous items.
- Winners from the State included two of our winners here on Maui
 - Kelly stated that she would like to reach out directly to the Art Teachers for the next Poster Contest held
- Arbor Day Update
 - Kelly stated that she had participated in the Arbor Day event and that it was well-attended
- HFUU Convention
 - Kelly stated that she had participated in the HFUU convention held in December, however, it was not as well-attended as Arbor Day, possibly because it was held on a Friday instead of a Saturday

NRCS Updates by Gerald Gregory, District Conservationist

- Mr. Gregory stated that they are currently in the middle of the contracting period, but he
 expects to see more conservation plans, EQIP and Farm Bill plans in June or July
- Mr. Gregory stated that JB Martin, the Acting NRCS-PIA Director had been confirmed as the new NRCS-PIA Director
 - Mr. Gregory is trying to get Mr. Martin to Hana to see the invasive Miconia and Turkey Berry there. He asked what might be concerns on the Westside that he could also take Mr. Martin to see
 - A suggestion of the Lahaina Watershed Project might be valuable for Mr.
 Martin to see
 - The board agreed that they needed to be brought up to speed on the project prior to presenting this to Mr. Martin
 - Mr. Gregory will reach out to Sharon Sawdey with NRCS to potentially set up small meetings with various board members.
- Conservation Stewardship Program (CSP) Plan for Approval
 - Please note that due to privacy laws, many aspects of the Conservation plans may not be fully discussed in a public forum. The Board anticipates going into executive session pursuant to section 92-5(a)(3), to discuss and approve the Conservation Plans
 - Since there were no members of the public in attendance, Mr. Gregory shared the plan via screen-share and answered questions
 - The plan is a renewal for another 5 years and is a prescribed grazing plan
 - Kimo Falconer made the motion to accept the plan

- The motion was seconded by Kainoa Casco
- The motion was then voted on and passed unanimously
- Gerald Gregory, Natural Resources Conservation Services District
 Conservationist, asked that the board notify either Kelly Butler or himself
 about any Westside events supporting the SWCD/NRCS mission so
 arrangements can be made for joint participation in those events
 - o Mr. Nobriga asked if the Land Judging would be happening this year
 - Millie will follow up with Michelle Watkins from HACD for more detail about this year's Land Judging Contest
 - Mr. Nobriga suggested that the Farm Bureau be contacted in order to participate in AgFest this year
 - Kelly Butler will follow up
