- Approval of March 2025 meeting minutes. MM moves to approve. TK seconds. All in favor.
- Financial Update:

- No move to approve P&L Report and Balance Sheet since it's inaccurate, with a note that when there is going to be an evaluation of proposed corrected P&L Report and Balance Sheet, it'll be reflected on the agenda and updates will be sent to Directors beforehand.

3. Board Business:

- Presentation of Cooperative Agreements and Conservation Plans
 - BH
 - Being presented on behalf of KR: Cooperative Agreement for TMK 8-5-004:020 (por.). MM moves to approve. TK seconds. All in favor.
 - Cooperative Agreement for TMK 6-7-002:043 (por.). TK moves to approve. AN seconds. All in favor.
 - MG, presenting on behalf of SM
 - Cooperative Agreement for TMK 65001056, 65005009, 64003016. Cooperator was originally presented a few months ago but the TMK had different tenants on it. AN moves to approve. MM seconds. All in favor with the comment that there is a lot of dumping going on in the parcel. The Cooperator plans to clean up as best as possible with a potential plan to install a gate. The Cooperator hopes tenants discourage dumping from the public.

 - Conservation Plan for TMK 68002005 (por.). AN moves to approve. TK seconds. All in favor.

4. Partner updates:

- Natural Resource Conservation Service (NRCS)
 - All eligible applications for the Inflation Reduction Act (IRA) funding is being deferred with further guidance to be given in the future.
 - Local Working Group (LWG) meeting will be held late July to August but there's not an exact date right now. This date will be pinned down by next meeting.
 - NRCS-PIA is down 70 employees after the fork-in-the-road offer.
- O'ahu Resource Conservation & Development Council (ORCD)
 - Setting up funding to distribute \$400k in cost share to Perimeter Fencing for Feral Swine participants through two rounds of funding. Currently, the Phase I participants are being contracted and Phase II participants are being identified. O'ahu RC&D is inviting producers, farmers, and ranchers who are navigating issues with federal contracts to get in touch with them. Grant writing services for ranchers and farmers continues. \$39 million in funding was terminated previous Monday for Hawai'i Climate-Smart Commodities, something O'ahu RC&D participated in. Participants were invited to resubmit their proposals so there's a possibility of being re-awarded.
