- Oʻahu Resource Conservation & Development Council (ORCD). Merger preparations are proceeding. Strategic planning happening in October. OACA contract with West is up for renewal. End of June 2024. LJ: would the board wish to extend the contract at this time to enable consolidation? DE: this would be fine. AG: West Oʻahu before OACA had many partners that gave us money. Gave folks a choice. OACA provided services to the district. We don't want to assume funders. As long as the new fee is in line with current fees. LJ: will need to sort out who we'd like. District services are minimal. That's what the district needs is administration. We don't really do much else, anything else is done through the nonprofit. DE: if you could share a list of who those funders are, make sure we have historical perspective. AG: AS would have that. AG Move to extend the contract with OACA for administrative up to August 31st, and authorize to make arrangements related to this. AN. All in favor. Motion carried. A one line addendum to our current agreement.
